

ORDINANCE NO. _____

An ordinance amending Schedule "A" of Section 4.61 of the Los Angeles Administrative Code to include and provide salaries for the new, non-represented Bridge-to-Jobs Program classifications of Cement Finisher Worker Assistant, Cement Finisher Worker Trainee, Investigator Trainee, Maintenance and Construction Helper Assistant, Maintenance and Construction Helper Trainee, Traffic Painter and Sign Poster Assistant, and Traffic Painter and Sign Poster Trainee.

**THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:**

Section 1. Schedule "A" of Section 4.61 of the Los Angeles Administrative Code is amended to add the Bridge-to-Jobs Program classifications in proper order as follows:

| 3405 | Traffic Painter and Sign Poster Trainee | 2403 |

Sec. 2. Section 1 shall be operative on July 2, 2023.

Sec. 3. This ordinance shall be effective upon publication, pursuant to Charter Section 252(g).

Sec. 4. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.


