

ORDINANCE NO. 188420

An ordinance repealing Ordinance No. 181,557, adopted on January 21, 2011, which added a definition for “Downtown Design Guide Project Area” to Section 12.03, added Subdivision 30 to Subsection A of Section 12.22, and added Subdivision 7 to Subsection D of Section 16.05 to the Los Angeles Municipal Code to implement the standards and guidelines in the Downtown Design Guide.

**THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:**

Section 1. Ordinance No. 181,557, which added Section 12.22.A.30 to the Los Angeles Municipal Code in order to implement the standards and guidelines in the Downtown Design Guide, is repealed.

Sec. 2. Section 12.03 of the Los Angeles Municipal Code is amended to delete the definition of the term “Downtown Design Guide Project Area.”

Sec. 3. Subdivision 30 of Subsection A of Section 12.22 of the Los Angeles Municipal Code is deleted.


Sec. 4. Subdivision 7 of Subsection D of Section 16.05 of the Los Angeles Municipal Code is deleted.

Sec. 5. **SEVERABILITY.** If any portion, subsection, sentence, clause or phrase of this ordinance is for any reason held by a court of competent jurisdiction to be invalid, such a decision shall not affect the validity of the remaining portions of this ordinance. The City Council hereby declares that it would have passed this ordinance and each portion or subsection, sentence, clause and phrase herein, irrespective of the fact that any one or more portions, subsections, sentences, clauses or phrases be declared invalid.

Sec. 6. This ordinance shall be operative on January 27, 2025.

Sec. 7. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.


