Re: SUPPORT for Council File 24-0140-SI (Park, Krekorian, et al.)

Dear City Councilmembers:

Pacific Palisades Community Council (PPCC) has been the most broad-based voice of the Palisades since its founding in 1973. Our community is located between the Pacific Ocean and the Santa Monica Mountains and is entirely within the Very High Fire Hazard Severity Zone (VHFHSZ). Like numerous other Los Angeles communities, we have been impacted by the homelessness crisis for many years, with individuals who sleep on our sidewalks and camp overnight on our beaches and in our bluff and park areas, posing a high risk of fire and a threat to public health and safety.

Consistent with PPCC's Mission "to protect and improve the quality of life in Pacific Palisades" (<https://pacpalicc.org>), PPCC has long supported appropriate regulation of overnight camping in public spaces, including the use of LAMC 41.18 as a tool to protect public health and safety and encourage service-resistant individuals to accept services and housing. PPCC also supported the amicus brief filed with the Supreme Court in the *Grants Pass* case by our neighboring council to the east, Brentwood Community Council (BCC). For these reasons, PPCC strongly supports the motion in CF 24-0140-SI, calling for the City Attorney to analyze the impact of the *Grants Pass* ruling – that anti-camping laws do not violate the 8th Amendment's prohibition against cruel and unusual punishment – on regulation of encampments in public spaces in Los Angeles, and further calling for a report by the Chief Legislative Analyst on current laws restricting camping in the 87 other cities in Los Angeles County that will impact the City of Los Angeles.
