These units have allowed moderately paid professionals like UCLA librarians and school teachers to live near their work. They have allowed moderately paid people to enjoy the same parks and the good schools that the rich folks of the westside enjoy. One would think that the council member for CD11 would be fighting to preserve this housing and to make it safe via an ordinance to close the loophole that allowed the landlord to avoid putting in life-saving sprinklers. One would think she would be fighting to help her tenant constituents. But instead, she appears to be fighting on the landlord's behalf, evoking a verbal opinion by the city attorney (who herself is on record as opposing affordable and low-income housing in Venice). What does "intervention" mean when she moves that the City Attorney "report on options for further intervention as previously requested in CF 23-4079." I cannot find this earlier CF 23-4079 so I am left to wonder if she means intervention on the landlord's behalf. I am aware that this particular landlord, Douglas Emmett, donated \$300,000 to support the councilwoman's election. Money talks.
