The CIS process was enabled by the to Los Angeles Administrative Code §Section 22.819. It provides that, "a Neighborhood Council may take a formal position on a matter by way of a Community Impact Statement (CIS) or written resolution." NCs representatives also testify before City Boards and Commissions on the item related to their CIS. If the Neighborhood Council chooses to do so, the Neighborhood Council representative must provide the Commission with a copy of the CIS or resolution sufficiently in advance for review, possible inclusion on the agenda, and posting on the Commission's website. Any information you can provide related to your agenda setting schedule is helpful to share with the NC.

If the CIS or resolution pertains to a matter *listed on the Commission's agenda*, during the time the matter is heard, the designated Neighborhood Council representative should be given an opportunity to present the Neighborhood Council's formal position. We encourage becoming familiar with the City Council's rules on the subject. At the Chair's discretion, the Neighborhood Council representative may be asked to have a seat at the table (or equivalent for a virtual meeting) typically reserved for City staff and may provide the Neighborhood Council representative more time than allotted to members of the general public. They are also permitted up to five (5) minutes of time to address the legislative body. If the CIS or resolution pertains to a matter *not listed on the agenda*, the designated Neighborhood Council representative may speak during General Public Comments.

Community Impact Statement on Council File 23-0243
(Federal Immigration Enforcement / City Resources, Property, Personnel / Prohibit Use /
Compliance Monitoring Report)

Position: Support

We know that, despite the patently false propaganda promulgated by Former President Trump during his first term and during the years since, the vast majority of undocumented immigrants are honest and hard-working people simply trying to make a better life for their families. A very large portion of them fled from oppressive regimes that were put in power, or stay in power because of misguided American Foreign Policy supported by both Republican and Democratic administrations. They are now here leading productive lives and contributing to our society and its infrastructure. Considering our national complicity in creating the conditions that have made conditions in their countries so intolerable, and out of respect to the invaluable contribution they make to our country, we should take heed to the call and the promise engraved on a bronze plaque mounted to the base of the Statue of Liberty: “Give me your tired, your poor, your huddled masses yearning to breathe free, the wretched refuse of your teeming shore. Send these, the homeless, the tempest-tost to me. I lift my lamp beside the golden door!”

Let us not forget this national ideal, even if our national leaders have. Let us do our best to make sure that all Angelenos, regardless of current immigration status, are treated with compassion and justice. Let us not let the bigotry and hatred that seems to have overtaken the leadership in our National Government run roughshod over our fellow Angelenos.

It is estimated that currently there may be as many as 2.2 million individuals within the LA Metro area that could find themselves targeted by the ill-considered actions promised by President-elect Trump. This is roughly 16% of the population. To upend the lives of such a significant portion of our population is unconscionable, and sure to have a significant impact on not only their lives but on the lives of every Angeleno. This could lead to concerns over public safety and relationships with law enforcement and undocumented victims of domestic violence and other related crimes. Sanctuary cities have statistically proven to have lower crime rates relative to those that don't have sanctuary status.

Mass deportation of this size would also depress rather than improve our current job market and the overall economy of the city of Los Angeles jobs such as food processing and preparation, custodial services, maintenance, construction, landscaping workers, IT & technology, healthcare, and more. Surely there is a better solution to the undocumented immigrant problem than the simple-minded solution proposed by the Trump administration.

For these reasons and others, the Reseda Neighborhood Council supports [Council File 23-0243](#) and urges its expedited approval.
