The Board of Building and Safety Commissioners, at its meeting of June 25, 2024, gave consideration to the application by Arpad and Katherine Domyan TRS – A and K Domyan Trust to export 3,796 cubic yards of earth from the above-referenced property.

The Board took the following action:

1. DETERMINED that the project is categorically exempt under CEQA pursuant to Section 15301 (Class 1) and Section 15303 (Class 3) of the California Environmental Quality Act (CEQA) Guidelines (Case No. ENV-2022-8439-CE), and there is no substantial evidence demonstrating that an exception to a categorical exemption pursuant to CEQA Guidelines, Section 15300.2 applies.
2. APPROVED the application subject to all conditions specified in the Department's report dated June 19, 2024, with the following exceptions:
 - a. Item C.6 shall be modified as follows:

All workers' vehicles, including those used for grading work and hauling activities, must be (i) parked on site or (ii) outside of the Bird Streets Area, and workers shuttled to the site. (DOT)
