





Subject: **THE LOS ANGELES DEPARTMENT OF WATER AND POWER PROPOSED RESOLUTIONS AUTHORIZING AMENDMENTS TO TWO AGREEMENTS, NO. 47804 WITH URS CORPORATION AMERICAS AND NO. 47805 WITH KLEINFELDER WEST, INC. FOR AS-NEEDED GEOTECHNICAL ENGINEERING, DAM AND RESERVOIR SAFETY INSPECTIONS AND RELATED SERVICES FOR THE VAN NORMAN COMPLEX PROJECTS IN GRANADA HILLS**

### RECOMMENDATION

That the Mayor:

1. Approve the Los Angeles Department of Water and Power proposed Board Resolutions authorizing an amendment to Agreement No. 47804 with URS Corporation Americas and an amendment to Agreement No. 47805 with Kleinfelder West, Inc. to increase the value of each Agreement by \$500,000, for a total contract amount of \$32,500,000, and \$27,500,000 respectively; and extend the term up to one year from May 28, 2024 to May 27, 2025 for a total contract term of 16 years for as-needed geotechnical engineering services, dam and reservoir safety inspections, and related services for the Van Norman Complex Projects; and,
2. Return the proposed Resolutions to the LADWP for further processing, including Council consideration.

### SUMMARY

The Los Angeles Department of Water and Power (LADWP) requests approval to execute an amendment to Agreement No. 47804 with URS Corporation Americas (URS) and Agreement No. 47805 with Kleinfelder West, Inc. (Kleinfelder) to increase the value of each Agreement by \$500,000, and extend the term by an additional one year, for a total term of 16 years to support as-needed geotechnical engineering services, dam and reservoir safety inspections and related services for the Van Norman Complex Projects. The URS Agreement will be increased from \$32,000,000 to \$32,500,000 and the Kleinfelder Agreement will be increased from \$27,000,000 to \$27,500,000. Both original Agreements expire on May 27, 2024 and will be extended through May 27, 2025, providing

continuity until the current competitive process and agreements are approved by the Board of Water and Power Commissioners (Board), whichever is earlier. The LADWP has completed negotiation of the new agreements and they are pending receipt of a Notice of Compliance by labor partners International Brotherhood Electrical Workers (IBEW), and subsequent approvals by the Board, Mayor's Office and City Council. The specialized services provided to the LADWP Water System and Van Norman Complex Projects are technical and related to geotechnical engineering support and related fields, including emergency operations, tunnel expertise, mitigation of emergency conditions, and assistance with mandated dam and reservoir third party inspections required by the California Department of Water Resources

The proposed Agreements and Resolutions have been reviewed and approved as to form by the City Attorney. Pursuant to Charter Section 373, and Los Angeles Administrative Code Section 10.5(e), the proposed Agreements require City Council approval as the total terms exceed five years. Our Office has reviewed the request and recommends approval.

## **BACKGROUND**

In the ongoing effort to provide safe, reliable, clean water to the residents, LADWP relies on consultant support for specialized and technical services to complete project planning, design, operations and maintenance, including emergency services. Under the original contracts, URS and Kleinfelder perform geotechnical services, dam and reservoir safety inspections, staff development and related services for the Van Norman Complex Projects located in Granada Hills in Council District 12. The contracts were established to provide as-needed geotechnical engineering, dam and reservoir safety inspections, and related services for the Los Angeles Reservoir Quality Improvement Project, Van Norman Complex Water Quality Masterplan and the Van Norman Complex Storm Water Capture Program, collectively referred to as the Van Norman Complex Projects. The scope of the service was expanded in 2012 to include support for all of LADWP's Water System projects.

*Prior Competitive Selection Process* – In November 2007, the LADWP released Request for Proposal No 171-08 seeking proposals from consultants for as-needed geotechnical services, dam and safety reservoir, staff development and related services for the Van Norman Complex Projects Geotechnical Services. Two proposals were received by the due date of February 4, 2008 and scored using a best-value selection methodology by an Evaluation Committee consisting of LADWP employees and one external member from the Metropolitan Water District of Southern California. After review, the Committee selected both firms to ensure that sufficient and adequate resources are available to assist LADWP. The URS and Kleinfelder Agreements were approved by the Board of Water and Power Commissioners on March 17, 2009, and the City Council on May 19, 2009 (Council File No. 09-0613) for an initial three year term, with four three-year extension options. The total cumulative term was from May 28, 2009 through May 27, 2024.

*Proposed Amendments and Cost* – The proposed Amendments will increase the contracts by \$500,000 each, and extend the current 15 year term for one additional year for a total term of 16 years from May 28, 2024 to May 27, 2025. The URS total contract amount will increase from \$32,000,000 to \$32,500,000, and the Kleinfelder total contract amount will increase from \$27,000,000 to \$27,500,000 as outlined in Table A. The additional time and funding requested will prevent a disruption in service and minimize the gap in critical services for as-needed services as the new

Agreements are making their way through the approval process. The new Agreements are anticipated to be in place by late 2024 pending receipt of a Notice of Compliance (NTC) by labor partners IBEW, with subsequent approvals by the Mayor’s Office, Board and City Council. The Department is requesting approval in advance of receipt of the NTC in anticipation of its approval given the pending expiration.

The Department reports the total amount of work authorized under the URS Agreement is \$31,757,008 with \$28,307,073 expended as of April 30, 2024; and under the Kleinfelder Agreement, the total amount authorized is \$26,149,513 with \$20,363,272 expended as of April 30, 2024. The Department anticipates limiting the scope of work for the extension year to critical tasks such as emergency operational work, meeting regulatory requirements, and specialty mandated work to ensure dam and reservoir safety and assumes expenditure levels to be no more than \$500,000 per contractor. LADWP is the owner and operator of 38 dams, 32 in the Water System and six in the Power System.

*Pending NEW Agreements* - In February 2022, Water Engineering and Technical Services Division initiated the process to establish new 10-year agreements that will provide the Water System with as-needed geotechnical services. However, it is anticipated that there will be a gap of several months as the new agreements are not expected to be in-place by mid/late 2024, pending the receipt of a Notice of Compliance and subsequent Board and City Council approvals. In the meantime, critical geotechnical engineering services are necessary on an as-needed basis, particularly those related to dam and reservoir safety, emergency operations, State and Federal-dictated regulatory compliance activities, and specialized expert services to mitigate conditions that could lead to dam and reservoir emergencies.

*Alternatives Considered* – The Department considered two alternatives; the first alternative is to transfer the work performed from both consultants to staff. This is not a viable option as LADWP staff do not have the specialized knowledge and expertise required to perform services provided. In addition, the dam and safety compliance requirements by the Division of Safety of Dams within the Department of California State Water Resources, require an outside third party review and inspection. The second alternative is to allow the Agreements to expire until the new Agreements are completed. This option is also not viable, as LADWP would be without critical technical and specialized services should emergencies arise.

## **CITY COMPLIANCE**

*Small Business Enterprise (SBE), Disabled Veterans Business Enterprise (DVBE), Minority Business Enterprises (MBE) / Women Business Enterprises (WBE) / Other Business Enterprises (OBE) Participation* - The original Agreements were issued prior to the implementation of the mandatory SBE/DVBE Participation Program. A Good Faith Effort outreach requirement was included in the original agreements. URS and Kleinfelder committed to 15 percent MBE and seven percent WBE utilization. Refer to Attachment 1, Procurement Summary for detailed actual subcontractor participation commitments by subcontractor.

*California Environmental Quality Act (CEQA)* – Under the CEQA Guidelines 15060 (c)(3), these Amendments are considered exempt. In accordance with this Section, an activity is not subject to CEQA if it does not meet the definition of a project. Section 15378(b)(4) states that government fiscal activities that do not involve any commitment to any specific project which may result in a potential significant physical impact on the environment do not meet that definition.

The proposed Amendments include provisions to ensure compliance with applicable City Ordinances, contracting and insurance requirements. The City Attorney has reviewed and approved the proposed resolutions and the Amendments as to form. In accordance with the Charter Section 373 and the Los Angeles Administrative Code Section 10.5(e), all LADWP agreements over five years require City Council approval. Our Office recommends approval.

## **FISCAL IMPACT STATEMENT**

Approval of the proposed Amendments to Agreement No. 47804 with URS and Agreement No. 47805 with Kleinfelder for as-needed geotechnical engineering services for the Van Norman Complex Projects, will not have an impact on the General Fund. The amount of the original Agreements will be increased by \$500,000 each for a total not to exceed amount of \$32,500,000 and \$27,500,000, respectively. The combined \$1 million is provided from the Water Revenue Fund. The recommendations in this report comply with the LADWP's adopted Financial Policies.

**SUBJECT:** Amendment No. 1 to Agreement No. 47804 with URS Corporation Americas and Agreement No. 47805 with Kleinfelder West, Inc. for the Van Norman Complex Projects Geotechnical Services

**SUMMARY**

Proposed Amendment No. 1 (Amendment) to Agreement Nos. 47804 and 47805 for the Van Norman Complex Projects Geotechnical Services (Agreements) will ratify and increase the value of each Agreement amount by \$500,000 (budgeted) and extend the Agreement terms by up to one year. The additional budget and time extension is required to minimize a gap in critical services while new as-needed geotechnical engineering professional services agreements are being established. The Amendments will be effective for up to one year or until the new agreements are approved by the Board, whichever is earlier. LADWP may elect to terminate the Agreements before the end of the one-year term, contingent upon Board approval of new Geotechnical Engineering As-Needed Services agreements which are currently under development. All other terms and conditions of the Agreements will remain unchanged.

The Agreements provide the Water System (WS) with expertise in geotechnical engineering and related fields to mitigate and assist in dam and reservoir emergencies, and to satisfy regulatory compliance for mandatory third-party reviews and inspections.

City Council approval is required in accordance with Charter Section 373.

**RECOMMENDATION**

It is requested that the Board of Water and Power Commissioners (Board) adopt the attached Resolution recommending City Council’s approval of the Amendments to Agreement No. 47804 with URS Corporation Americas, an AECOM Company (URS) and Agreement No. 47805 with Kleinfelder West, Inc. (Kleinfelder) as required in Charter Section 373.

**ALTERNATIVES CONSIDERED**

The following alternatives were considered to continue critical geotechnical engineering and related services:

The first alternative would be a transfer of tasks supported by URS and Kleinfelder to LADWP staff. This is not a viable option because LADWP does not have the experience and expertise to perform some of the critical services that may be required. Further, LADWP cannot meet regulatory compliance for mandated third party reviews and inspections.

Another alternative would be to allow the Agreements to lapse until new agreements for these services are completed. Such a gap in critical services is not recommended because LADWP will be without critical technical and specialized services related to dam and reservoir safety, emergency operations, tunnel expertise, and mitigation of emergency conditions. LADWP cannot meet regulatory compliance, including State and Federal mandates for third party reviews and inspections of LADWP projects.

**FINANCIAL INFORMATION**

The terms of the current Agreements expire on May 27, 2024. The Amendments will ratify and extend each Agreement term by up to one year for a total term of up to sixteen years and increase each Agreement amount by \$500,000, for a total additional amount of \$1,000,000 (budgeted).

**BACKGROUND**

URS and Kleinfelder were awarded Agreement Nos. 47804 and 47805 by LADWP Board of Commissioners on May 28, 2009 (Resolution 009 207) as the result of a competitive Request for Proposals process, with not-to-exceed amounts of \$32 million and \$27 million, respectively, to provide as-needed geotechnical services, dam and reservoir safety, staff development, and related services for the Van Norman Complex

Projects Geotechnical Services. Throughout the duration of these Agreements, these consultants provided technical expertise on an as-needed basis for specialized work outside of LADWP's core functions (e.g. assisting in updating all mandated WS Dams Emergency Action Plans to meet State regulation, peer review through the establishment of expert panels, and dam design and construction expertise) and to augment internal design staff during peak project demand.

The Agreements, including all optional extensions, expire on May 27, 2024. In February 2022, Water Engineering and Technical Services Division (WETS) initiated the process to establish new 10-year agreements that will provide the WS with as-needed geotechnical services, however, it is anticipated that there will be a gap of several months until the new agreements are established. The new agreements are expected to be in-place by mid/late 2024, pending the receipt of a Notice of Compliance and Board and City Council approval. In the meantime, critical geotechnical engineering services are necessary on an as-needed basis, including those related to dam and reservoir safety, emergency operations, State and Federal dictated regulatory compliance activities, and specialized expert services to mitigate conditions that could lead to dam and reservoir emergencies. For these reasons, LADWP is seeking to ratify and amend the existing Agreements by extending the terms by up to one year or until the new agreements are approved by the Board, whichever is earlier, and increasing the not-to-exceed amount by \$500,000 for each Agreement.

In accordance with the Mayor's Executive Directive No. 4, the City Administrative Officer's Report has been requested.

### **ENVIRONMENTAL DETERMINATION**

In accordance with this section, an activity is not subject to CEQA if it does not meet the definition of a project. **WHEREAS**, URS Corporation Americas and Kleinfelder West, Inc., were awarded Agreement Nos. 47804 and 47805 (Agreements) by the Los Angeles Department of Water and Power (LADWP) Board of Water and Power Commissioners of the City of Los Angeles (Board) on May 28, 2009 (Resolution 009 207), each for a term of three years with up to four, three-year renewal options and not-to-exceed amounts of \$32 million and \$27 million, respectively, to provide geotechnical services, dam and reservoir safety, meeting State and Federal regulatory compliance, effectively responding to emergencies, staff development, and related services on an as-needed basis for LADWP projects included in the Water System's Capital Improvement Program and the Operations and Maintenance Program; and
