PROPOSED ZONE CHANGE AND HEIGHT DISTRICT CHANGE AT 5601-5673 WEST SANTA MONICA BOULEVARD, 5612-5666 WEST VIRGINIA AVENUE AND 1110-1118 NORTH WILTON PLACE, CF TBD

Pursuant to the provisions of Section 551, 555 and 558 of the City Charter, transmitted herewith is the August 10, 2023 action of the City Planning Commission recommending approval of a proposed Zone Change and Height District Change, from R4-1VL and C4-1VL to (T)(Q)C4-2D, for the proposed demolition of an existing vacant commercial building and surface parking lot for the construction, use, and maintenance of approximately 510,621 square feet of film and television production studios, creative offices, retail, and accessory related uses with on-site associated parking.

The City Planning Commission, as evidenced by the attached Findings, has determined that the proposed zone change and height district change will conform to the City's General Plan, will be compatible with adjacent land uses, and is appropriate for the site.

1. Concur in the attached Action of the City Planning Commission relative to its recommended approval of the recommended Zone Change and Height District Change for the subject property, with the attached conditions of approval;
