As recommended in the accompanying report of the Director of the Bureau of Street Lighting, which this Board has adopted, the Board of Public Works recommend that your Honorable Body:

1. ADOPT in accordance with Section 6.98 of the Administrative Code of the City of Los Angeles, with the recommendations that:

a. Council adopt this report and the Ordinance of Intention for the Los Angeles City Street Lighting Maintenance Assessment District (LACLD), under which individual maintenance assessments, and the composition of the district will remain substantially the same as in 2023/24, and therefore assessments will be exempt from the "procedures and approval process" (Section 4 of Proposition 218) as allowed in section 5 of Proposition 218. **ANNUAL ASSESSMENT FOR STREET LIGHTING MAINTENANCE AND OPERATION FOR
2024/25 – LOS ANGELES CITY LIGHTING DISTRICT (ASSESSMENTS AND DISTRICT
FROZEN SINCE 1996)**

Recommending the Board:

1. ADOPT and FORWARD this report and transmittals to the City Clerk and City Council in accordance with Section 6.98 of the Administrative Code of the City of Los Angeles, with the recommendations that:
 - a. Council adopt this Report and the Ordinance of Intention for the Los Angeles City Street Lighting Maintenance Assessment District (LACLD), under which individual maintenance assessments, and the composition of the district will remain substantially the same as in **2023/24**, and therefore assessments will be exempt from the "procedures and approval process" (section 4 of Proposition 218) as allowed in section 5 of Proposition 218. **No assessments will be increased and no properties will be added to this district, therefore, no ballots will be required.**
 - b. Proceedings for the maintenance of the LACLD for fiscal year **2022/23** be conducted in conformance with Division 6, Chapter 3, Article 1 of the Los Angeles Administrative Code, California Government Code Section 53753.5 and Proposition 218 (Articles XIII C and XIII D of the California State Constitution). **At the conclusion of the Council Public Hearing, assessments be confirmed and an ordinance levying the assessments be adopted.** Confirmation of the assessments by **July 31, 2024** is necessary to meet the County deadline for inclusion of the assessments on the **2024/25** Property Tax Bills.

FISCAL IMPACT STATEMENT

Approval will result in assessment revenue of about **\$42,300,000** to the Street Lighting Assessment Fund (SLMAF) for **2024/25** street lighting operations, slightly **less** than in 2023/24. An amount of **\$2,600,000** is budgeted from the Water and Electricity Fund for the City's share of the Public Property assessments. About 510,000 parcels are included in this assessment district.

SUMMARY DISCUSSION

Approval of this report, adoption of the Ordinance of Intention, holding of the public hearings, and adoption of the Final Ordinance by Council, with approval by the Mayor, is required under Sections 6.95 to 6.127 of the Los Angeles Administrative Code to levy the assessments needed to operate the Los Angeles City Street Lighting Maintenance Assessment District (LACLD) for **2024/25**. The **\$47,000,000** in annual assessments is the primary source of revenue for the Bureau of Street Lighting's operating budget and other street lighting expenses. The assessments are collected through the County Property Tax Bills, and therefore the assessments must be confirmed by the Council by **July 31, 2024** to ensure that the information can be included on the tax bills.

In summary, the total estimated cost of LACLD street lighting operations for **2024/25** is **\$55,888,850** of which **\$42,300,000** is proposed to be assessed to benefiting properties, including City-owned properties, in accordance with established Council policy. The remaining **\$40,654,150** (**\$1,645,850** carry over from previous fiscal year) in costs are funded from other sources of revenue, including miscellaneous receipts, reimbursements from other agencies, and collections for damage claims, permits & fees, and maintenance agreement receipts. An appropriation of **\$2,600,000** from the Water & Electricity Fund is budgeted for the public property street lighting maintenance assessments.

SINCE INDIVIDUAL MAINTENANCE ASSESSMENTS, AND THE COMPOSITION OF THE DISTRICT WILL REMAIN SUBSTANTIALLY THE SAME AS IN 2022/23, THEY ARE EXEMPT FROM THE "PROCEDURES AND APPROVAL PROCESS" (SECTION 4 OF PROPOSITION 218) AS ALLOWED IN SECTION 5 OF PROPOSITION 218. NO ASSESSMENTS WILL BE INCREASED AND NO PROPERTIES WILL BE ADDED TO THIS DISTRICT.

SIGNIFICANT ITEMS AFFECTING THE ESTIMATE

REVENUES

- **STREET LIGHTING MAINTENANCE ASSESSMENTS** – The Bureau collects 98% of all assessments levied against benefiting property owners.
- **ACCELERATED HIGH VOLTAGE CONVERSION PROGRAM (MICLA)** – The Bureau will be converting the remaining 456 high voltage streetlights to energy efficient low voltage LED streetlights next fiscal year.

EXPENDITURES

- **ELECTRIC RATES** – The annual bills for electricity for the LACLD are estimated to total **\$10,652,489** for **2024/25**.
- **STREET LIGHTING MAINTENANCE ASSESSMENT FUND (SLMAF)** – The SLMAF covers design, operation, and maintenance of the street lighting system (~220,000 streetlights).

OTHER SIGNIFICANT ITEMS

- **REVIEW OF ASSESSMENT FUND REVENUES** – In fiscal year **2024/25** the Bureau will be reviewing the assessment fund to ensure that all assessments are accurate and being properly collected.
- **CITYWIDE ASSESSMENT BALLOT** – In fiscal year 2016-2017, the Bureau worked with a consultant to establish a detailed plan for a Citywide LACLD ballot proceeding. The consultant concluded its study and recommendation in fiscal year 2017-18 to move forward with the LACLD ballot. The CAO's Needs Analysis Report contract was completed in FY 2019-20. The Bureau awarded a personal service contract in 2021 to NBS Government Finance, Inc. for a database software that will calculate street lighting maintenance assessments for over 550,000 parcels. The Board Adopted our Supplemental Agreement No. 1 with NBS on May 18, 2022 and the Agreement was Executed on June 22, 2022. Supplemental Agreement No. 1 added nine (9) months to the original Contract end date of December 10, 2021 thereby extending the end date to September 7, 2022. The terms and language in the Supplemental Agreement No. 1 allowed us to extend the Agreement with NBS by providing NBS written notice on a month-to-month basis for a maximum of 6 months to March 7, 2023. The First Amendment to Supplemental Agreement No. 1 with NBS added 12 months to the Contract and was Executed on October 17, 2023 thereby extending the Contract end date of March 7, 2023 to March 7, 2024. The terms and language in the First Amendment to Supplemental Agreement No. 1 allows us to extend the Agreement with NBS by providing NBS written notice on a month-to-month basis for a maximum of 6 months to September 7, 2024.
Note: Any Citywide Ballot activity will be at the discretion of the Board and Council.
- **WIRE THEFT** – The City of Los Angeles has over 223,000 streetlights that are supported by a vast underground network of approximately 9,000 miles of conduit filled with 27,000 miles of copper wire that connect to 12,000 DWP service points. Historically, before FY 17/18, theft and vandalism incidents remained relatively steady, averaging around 900 annually. However, since FY 17/18, these incidents have surged nearly eightfold, establishing a new normal of all-time highs. Presently, with over 3200 theft and vandalism incidents recorded, this fiscal year seems poised to maintain this elevated trend. While it's premature to discern a consistent pattern, the Bureau perceives a new plateau in copper wire theft and vandalism within the City. Key measures, such as deploying high-strength, lockable pullboxes and bolstering LAPD and public awareness, have proven pivotal in addressing this persistent challenge.
- **EV CHARGING STATIONS** - Innovative curbside Streetlight EV Charging Stations attach to the streetlight and utilize the existing circuitry, making them extremely cost-effective. Our first Infrastructure as a Service solution is expanding to meet the mandate set by the Mayor's Sustainable plan to increase EV adoption 25%, adding 100,000 new electric vehicles in the City by 2025.
- **VISION ZERO** - Vision Zero Los Angeles is premised on the fundamental principle that loss of life by traffic collision is unacceptable. The goal of Vision Zero is to target all traffic fatalities with an emphasis on the most vulnerable users of our streets; people who walk and bicycle. Our Bureau has improved over 450 locations. The Bureau has developed a list of prioritized lighting projects to improve safety on the

High Injury Network which identifies streets with a high concentration of traffic collisions that result in severe injuries and deaths. We will continue to incorporate strategies into intersections and crosswalks at mid-blocks to improve safety.

- **FIRST 5G CITY IN THE NATION** - Technology continues to evolve such that access and connectivity to our street lighting poles is in high demand. As the use of smartphones, live-streaming, and other communication devices increases, the demand for, and proliferation of, additional antennas and communication cabinets increases. The City took an innovative approach to reduce the installation of cabinets or additional antenna poles on our sidewalks and decided to combine the needed equipment with existing street light poles, hence Co-Location. The Co-Location Program facilitates this effort through the installation of communication devices/antennas to be attached to or placed within the City's existing streetlight poles. This work includes the replacement of poles, installing larger, stronger foundations, and, when required, rewiring of circuits. The Bureau of Street Lighting coordinates with telecommunication companies, provides designs, coordinates with City crews, and performs administration duties. There are currently over 3828 Co-Location poles citywide. The Bureau's rigorous engineering and design standards are resulting in more innovative street light designs, and sleeker integrated poles. These more advanced, aesthetically pleasing poles will strengthen the City's cellular coverage for constituents, businesses, and visitors. We developed a brochure detailing the function of 5G and integrated small cells, safety, and benefits to keep the community informed on small cell attachments.
- **CONDUIT, FIBER, AND TECHNOLOGY DEPLOYMENT SUPPORTING STREET LIGHTING OPERATIONS** – Building off of the Bureau's ongoing efforts to install wireless remote monitoring nodes to track the operational status of streetlights, the Bureau has begun deploying fiber optic cables in key areas to further improve lighting operations. Fiber optic technology allows for significantly higher data transfer over wireless deployments, allowing for the implementation of new types of sensors and tools that will foster greater efficiency and lighting control while also improving the security of our infrastructure against theft and vandalism. In conjunction with the Bureau's new state-of-the-art Operations Management System, this new technology will allow the Bureau to pinpoint issues, improve lighting conditions, and track overall performance – all while providing a platform for the development of new Smart City services and applications.

PROPOSITION 218

Shortly after approval of Proposition 218 on November 5, 1996, we conferred with experts in assessments in the private sector, in other cities, and within the City, including the City Attorney, CAO, CLA, City Clerk and others to ascertain and deal with the impacts on assessments, particularly for this District. Our conclusions, concurred in by the City Attorney, are:

1. This assessment district can be renewed, a year at a time, and is exempt from the voting, mailed notices and other requirements of Proposition 218, Section 4, as long as the assessments and the composition of the District are not increased or added to from the previous year.
2. When an increase becomes necessary, a ballot and notice must be mailed to all property owners in the District; if a weighted majority of the votes received are against the increased assessment, it cannot be levied.

STREET LIGHTING MAINTENANCE ASSESSMENTS – FINAL ESTIMATE

Transmittal No. 2 is the FINAL ESTIMATE of expenditures and revenues for the **2024/25** LACLD. It also provides a description of the cost and revenue elements of the estimate, and the basis for the street lighting maintenance assessments that are levied by City Council.

The assessments to about 510,000 individual properties (about 2/3 of the City) will remain the same as in **2023/24**. Properties without streetlights (about 1/3 of the City) are not assessed. A typical R-1 property with a 50-foot frontage which was assessed \$53.07 in **2023/24** will be assessed the same amount in **2024/25**.

This estimate has been prepared consistent with Council Policy in Administrative Code Sections 6.95-6.127, and on the basis of maintaining the Street Lighting Maintenance Assessment Fund in a solvent condition throughout the next fiscal year. The major portion of the revenue to this Fund is planned to be secured from the annual assessment to benefiting properties, which comprise the LACLD. The Bureau of Street Lighting (BSL) budget is also financed from the SLMAF. Therefore, we depend on reimbursement of design fees and other charges to the SLMAF from other funds and agencies.

PROCEDURES FOR CONFIRMING THE ASSESSMENTS

Upon approval of this report and adoption of the Ordinance of Intention by the Council, dates will be set for hearing appeals, one hearing at the Board of Public Works, and then one hearing at the Council. After consideration of the appeals, Council may vote to confirm the assessments, and to adopt a Final Ordinance ordering the maintenance work to be done and the assessments to be levied. ***This must be completed in time to submit the necessary information to the County***

Tax Collector for inclusion with the Property Tax Bills, to avoid a costly, separate City billing preparation, mailing and collection. The Council must confirm the assessments by July 31, 2024 to be included in the County Property Tax Bills.

The assessment diagrams of lands previously approved for assessments, except for assessments first confirmed in 1996/97 and thereafter, are available, and the roll of individual assessments proposed to be levied within the district is being prepared by our assessment engineering staff. These documents will be available prior to the publication of the Notice of Public Hearing. The Ordinance of Intention for the LACLD has been approved as to form by the City Attorney.

ORDINANCE NO. _____

An Ordinance pursuant to the provisions of Section 6.95 - 6.127 of the Los Angeles Administrative Code, Sections 53753.5 of the California Government Code, and Proposition 218 (Articles XIII C and XIII D of the California Constitution) declaring the intention of the Council of the City of Los Angeles to order the necessary street lighting systems to be operated, maintained and repaired, including furnishing electric energy, for a period of one year ending June 30, 2025 for the lighting of that certain district designated as the **LOS ANGELES CITY STREET LIGHTING MAINTENANCE ASSESSMENT DISTRICT** ("MASTER DISTRICT") in the City of Los Angeles. The "MASTER DISTRICT" was created for administrative convenience and is comprised of individual "COMPONENT DISTRICTS" created prior to the effective date of Proposition 218 to fund street lighting related services and/or activities.

The boundaries of the COMPONENT DISTRICTS and the individual assessments for each property within the COMPONENT DISTRICTS remain unchanged from the assessment year preceding the effective date of Proposition 218. No assessments will increase and no new properties will be added to the involved COMPONENT DISTRICTS. The city may from time to time delete all or a portion of COMPONENT DISTRICT from the MASTER DISTRICT but only if such change will not increase any individual COMPONENT DISTRICT assessment amounts beyond the last pre-Proposition 218 assessment amount. Such COMPONENT DISTRICTS are therefore exempt under section 5 of Proposition 218 from the procedures and approval process set forth in section 4 of Proposition 218.

**THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:**

Section 1. The public interest and convenience require, and it is the intention of the Council of the City of Los Angeles to order the following improvement to be made, to wit:

That the necessary street lighting systems be operated, maintained and repaired, including the furnishing of electric energy, for the period of one year ending June 30, 2025 for the lighting of:

All those streets, alleys, and other public places within the boundaries of the City of Los Angeles that have heretofore been assessed for such services for the period of one year ending June 30, 2024, except all those COMPONENT DISTRICTS assessed for the first time in 1996/97 and thereafter. The COMPONENT DISTRICTS to be assessed to pay the costs and expenses of this improvement shall collectively be known as the **"LOS ANGELES CITY STREET LIGHTING MAINTENANCE ASSESSMENT DISTRICT"** ("MASTER DISTRICT"). The lighting districts in such MASTER DISTRICT can also be described as those lighting districts with assessment diagram numbers 1

through 11161, not including assessment diagram numbers 9953, 10803, 11136, 11138 and 11140 through 11153, as more fully described in sections 2 and 4 herein.

Sec. 2. All of the said work shall be done in accordance with the report, prepared and approved by the Director of the Bureau of Street Lighting adopted by the Board of Public Works, therefore, approved by the City Council and on file in the office of the City Clerk. Reference to said report is hereby made for a full and detailed description of the proposed improvement and of the assessments to be levied.

Sec. 3. The said Council hereby makes all the costs and expenses of said improvement, including incidental expenses, chargeable upon the COMPONENT DISTRICTS to be benefited thereby, with no additional portion of the costs to be paid out of the City Treasury.

Sec. 4. The Council hereby determines and declares that the COMPONENT DISTRICTS which receive special benefit from said improvement and are to be assessed to pay the costs and expenses thereof, are described by the diagram included by reference in the said report of the Director of the Bureau of Street Lighting adopted by the Board of Public Works, which diagram indicates by a boundary line the extent of the territory included within each said COMPONENT DISTRICT. Reference is hereby made to said report and diagram for a full and complete description of said COMPONENT DISTRICTS, which diagram shall govern for all details as to the extent thereof. Diagrams showing the territory of the COMPONENT DISTRICTS are on file in the office of the Bureau of Street Lighting, 1149 S. Broadway, 2nd Floor, Los Angeles, California, 90015. All public streets and alleys or portions thereof are hereby excepted therefrom.

Sec. 5. That the proceedings for the said improvement shall be had and taken under and in accordance with Section 6.95 - 6.127 of the Los Angeles Administrative Code, Sections 53753.5 of the California Government Code, and Proposition 218 (Articles XIII C and XIII D of the California Constitution).


Sec. 6. The Board of Public Works shall cause notices of said improvement to be published in newspapers of general circulation published and distributed in the several areas of the City in the manner and form and within the time required by law.

Sec. 7. That _____ at the hour of 10 o'clock a.m. is the time, and the Council Chamber on the third floor of City Hall in the City of Los Angeles is the place, when and where a public hearing on the proposed improvement and assessment will be held by the City Council. Any person objecting to their assessment may file a written protest or appeal with the City Clerk at any time prior to this confirmation hearing by the City Council. Any person may also present written or oral comments at the City Council testimony meeting on this matter. Such protest must contain a description of the property in which each signer thereof owns an interest, sufficient to identify the property, and be delivered to the City Clerk, and no other protests than those presented within the time specified will be considered.

Sec. 8. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.

ORDINANCE NO. _____

An Ordinance pursuant to the provisions of Section 6.95 - 6.127 of the Los Angeles Administrative Code, Sections 53753.5 of the California Government Code, and Proposition 218 (Articles XIII C and XIII D of the California Constitution) declaring the intention of the Council of the City of Los Angeles to order the necessary street lighting systems to be operated, maintained and repaired, including furnishing electric energy, for a period of one year ending June 30, 2025 for the lighting of that certain district designated as the **LOS ANGELES CITY STREET LIGHTING MAINTENANCE ASSESSMENT DISTRICT** ("MASTER DISTRICT") in the City of Los Angeles. The "MASTER DISTRICT" was created for administrative convenience and is comprised of individual "COMPONENT DISTRICTS" created prior to the effective date of Proposition 218 to fund street lighting related services and/or activities.

The boundaries of the COMPONENT DISTRICTS and the individual assessments for each property within the COMPONENT DISTRICTS remain unchanged from the assessment year preceding the effective date of Proposition 218. No assessments will increase and no new properties will be added to the involved COMPONENT DISTRICTS. The city may from time to time delete all or a portion of COMPONENT DISTRICT from the MASTER DISTRICT but only if such change will not increase any individual COMPONENT DISTRICT assessment amounts beyond the last pre-Proposition 218 assessment amount. Such COMPONENT DISTRICTS are therefore exempt under section 5 of Proposition 218 from the procedures and approval process set forth in section 4 of Proposition 218.

**THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:**

Section 1. The public interest and convenience require, and it is the intention of the Council of the City of Los Angeles to order the following improvement to be made, to wit:

That the necessary street lighting systems be operated, maintained and repaired, including the furnishing of electric energy, for the period of one year ending June 30, 2025 for the lighting of:

All those streets, alleys, and other public places within the boundaries of the City of Los Angeles that have heretofore been assessed for such services for the period of one year ending June 30, 2024, except all those COMPONENT DISTRICTS assessed for the first time in 1996/97 and thereafter. The COMPONENT DISTRICTS to be assessed to pay the costs and expenses of this improvement shall collectively be known as the **"LOS ANGELES CITY STREET LIGHTING MAINTENANCE ASSESSMENT DISTRICT"** ("MASTER DISTRICT"). The lighting districts in such MASTER DISTRICT can also be described as those lighting districts with assessment diagram numbers 1

through 11161, not including assessment diagram numbers 9953, 10803, 11136, 11138 and 11140 through 11153, as more fully described in sections 2 and 4 herein.

Sec. 2. All of the said work shall be done in accordance with the report, prepared and approved by the Director of the Bureau of Street Lighting adopted by the Board of Public Works, therefore, approved by the City Council and on file in the office of the City Clerk. Reference to said report is hereby made for a full and detailed description of the proposed improvement and of the assessments to be levied.

Sec. 3. The said Council hereby makes all the costs and expenses of said improvement, including incidental expenses, chargeable upon the COMPONENT DISTRICTS to be benefited thereby, with no additional portion of the costs to be paid out of the City Treasury.

Sec. 4. The Council hereby determines and declares that the COMPONENT DISTRICTS which receive special benefit from said improvement and are to be assessed to pay the costs and expenses thereof, are described by the diagram included by reference in the said report of the Director of the Bureau of Street Lighting adopted by the Board of Public Works, which diagram indicates by a boundary line the extent of the territory included within each said COMPONENT DISTRICT. Reference is hereby made to said report and diagram for a full and complete description of said COMPONENT DISTRICTS, which diagram shall govern for all details as to the extent thereof. Diagrams showing the territory of the COMPONENT DISTRICTS are on file in the office of the Bureau of Street Lighting, 1149 S. Broadway, 2nd Floor, Los Angeles, California, 90015. All public streets and alleys or portions thereof are hereby excepted therefrom.

Sec. 5. That the proceedings for the said improvement shall be had and taken under and in accordance with Section 6.95 - 6.127 of the Los Angeles Administrative Code, Sections 53753.5 of the California Government Code, and Proposition 218 (Articles XIII C and XIII D of the California Constitution).


Sec. 6. The Board of Public Works shall cause notices of said improvement to be published in newspapers of general circulation published and distributed in the several areas of the City in the manner and form and within the time required by law.

Sec. 7. That _____ at the hour of 10 o'clock a.m. is the time, and the Council Chamber on the third floor of City Hall in the City of Los Angeles is the place, when and where a public hearing on the proposed improvement and assessment will be held by the City Council. Any person objecting to their assessment may file a written protest or appeal with the City Clerk at any time prior to this confirmation hearing by the City Council. Any person may also present written or oral comments at the City Council testimony meeting on this matter. Such protest must contain a description of the property in which each signer thereof owns an interest, sufficient to identify the property, and be delivered to the City Clerk, and no other protests than those presented within the time specified will be considered.

Sec. 8. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
