Subject: **GI TC ONE WILSHIRE LLC (GI TC) INFORMATION TECHNOLOGY SYSTEM FRANCHISE RENEWAL APPLICATION AND RECOMMENDATION APPROVAL (CF NO. 98-1597)**

## **Recommendation**

The Information Technology Agency (ITA) has reviewed the renewal application of the GI TC One Wilshire LLC (GI TC) Information Technology (I.T.) System franchise, granted in 2015 by City Council and Mayor, and recommends approval of said application request. Because I.T. System franchises are effectuated by ordinance, ITA also recommends Council to request that the City Attorney prepare and present a draft ordinance to City Council, with a ten-year term, allowing for the renewal of this franchise.

## **Background**

An I.T. System franchise is an encroachment permit that provides for the interconnection between two or more points in the public rights-of-way, utilized solely for signal transmission and not to serve any customer within the City.

In 2015, the City Council and Mayor granted a 10-year franchise renewal to GI TC for the placement of conduit in the City's public rights-of-way at 624 South Grand Avenue (See CF No. 98-1597 and Los Angeles City Ordinance No. 184401).

GI TC is now requesting approval to renew said I.T. System franchise for another 10 years.

## **Fiscal Impact**

Approval of the renewal of this I.T. System franchise will generate \$2,500 in application fees and \$4,800 in annual franchise fees over the next 10 years for a total of \$48,000 during the ten-year term of the franchise.
