**Comments for Public Posting:** I completely sympathize with the unfortunate conditions of the shelter system,s all over the U.S. I have been heavily involved in animal, mostly canine rescue for over 50 years, and have rescued vetted, spayed, neutered and placed thousands of animals in fantastic, well matched homes. BUT... suspending the rights of responsible, law-abiding breeders although you sympathize with the unfortunate conditions of the shelter system, suspending the rights of responsible, law-abiding breeders will not help shelter overcrowding. The key to the problem is education of the public. DO spay and neuter all pet animals. DO either get your pet from a LEGITIMATE RESCUE or SHELTER (there are a ton of scammers out there who only do this to make money.) New homes MUST be carefully checked out so the animals don't just end up back in another shelter!!!! Many of the animals in the shelters are "repeat offenders". They spend their lives being floated from one bad home, back to the shelter, back to another bad home, etc, etc., etc. We need free obedience classes, free spay neutering, free vaccines, help for the elderly or ill whose animals are their entire life, but they need help taking care of them. I've spent a lot of time at L.A. County and City shelters. The staff are underpaid, undertrained, overworked, and totally unappreciated as it is apparently felt by city leaders that they're not a necessity. This needs to change. Since Covid, things have just gotten worse and worse. I couldn't be at this meeting, but I hope my words are taken into consideration. People in general, need to be more responsible. An animal is a big responsibility and not a disposable object to be passed along when you get tired of it. I've been told that it would be easier to adopt a child than get a dog from me. A vast majority of the time though, animals I've placed, because I'm so careful to match the right animal to the right home, never return to me (even though that's one of my requirements). They live long, happy lives and their new families become part of my family of friends. There's so much that can be done to fix this problem, but banning conscientious breeders who care about there dogs and do things the right way, is not going to even make a dent. Those are not the dogs who end up in the shelters because a "real breeder" requires their dogs be returned to them if at any time in their lives they can't keep that dog. Walk down the aisles of the local city shelters some time if you feel like getting a reality

check. Everyone voting on this should have to do that BEFORE voting. The majority of dogs you will see there will be Pit Bulls, Chihuahuas, German Shepherds, Rottweilers, Poodles, small toy breeds, and a lot of big mixes. Most of the purebreds are obviously very poorly bred. Every other house on the block is "breeding" pits and chihuahuas, and the people doing that are doing it ONLY to make money off the backs of the animals. THOSE non law abiding people are the ones who need to have animals removed from their custody, they are most of the supply. They sell dogs to anyone with a credit care, and never check the home out. I wanted to volunteer at a local L.A. City shelter. They told me that "because of Covid" it wasn't as easy to volunteer as it used to be, and they also had a huge shortage of volunteers. THIS needs to be fixed too. I am a professional dog trainer/behaviorist. I've worked with a majority of dog breeds. I'm a photographer and a writer. I know I could be useful, but, I was essentially told to come back another time, they were too busy taking care of the animals. My heart breaks for those employees. Most of them love the animals, but they are really burned out and over worked. Their budgets have been cut, every time I've gone to a shelter in the past couple of years, they are turning away dozens of animals because they don't have the room or the workers to take care of them. Tell that new mayor that the homeless humans are not the ONLY ones who need help. Anyway, sorry for rambling on, but I feel very strongly about this. Enforce the laws that are already in place (which currently is NOT being done). Allow true experts and professionals to help educate the public. Spend some of those big bucks I pay in taxes on this issue. Free education, spaying, neutering, vet care help, even pet food for the elderly and poor. That's what it's going to take to fix this problem, not "bans" of law abiding, caring people.
