Comments for Public Posting: My name is Kaitlyn Quackenbush. I am the Assistant Director of Policy and Research at Strategic Actions for a Just Economy (SAJE). City Council and Council President should immediately pass the Tenant Anti-Harassment Ordinance in order to protect tenants from harmful harassment that happens day-in and day-out to tens of thousands of tenants and ultimately leads to “silent” evictions that go unrecorded. Do NOT weaken the remaining enforcement provisions. City Council should maintain the deterrent effect of the ordinance by keeping the fees at the levels proposed by HCID. Reducing the fees will mean more landlords will ignore the fees and continue to harass their tenants. The definition should remain broad because harassment can take many forms and it’s impossible to predict every kind of harassment possible. Harassment has always been a problem. Covid-19 makes it worse, but we need this now and for it be permanent going forward. It affects tens of thousands of renters every day in Los Angeles. Before eviction often comes harassment. Almost everyone who has been evicted has first harassed. Harassment is the practice of wearing down the human spirit that drives families with no other place to live out of their homes despite the often inevitable consequence of homelessness. Today we are seeing harassment manifest in the form of illegal lockouts which have spiked in recent months. The Tenant Anti-Harassment ordinance would prevent this type of escalation from happening in the first place. This is more important than ever because of the relationship between evictions and rising COVID19 infection rates. Protecting tenants from harassment is a matter of housing security and public health.
