Comments for Public Posting: Hi, My name is Clara I live in North Hollywood and I want to express my support for the Tenant Anti-Harassment Ordinance. Something I want to add based on personal experience is that harassment also leaves many tenants in an impossible situation where they accept dangerous living conditions out of fear of being evicted, sued, or physically harmed. Personally, me and my roommates were blamed for structural problems with the residence we lived in and ultimately received threats of physical violence from a previous landlord when we tried to ask for repairs. Though we ended up being able to stay until the end of the lease, the experience was very scary and left me feeling almost lucky to get away with just a stolen security deposit. It is in this way that landlords are economically motivated to harass their tenants— either in order to evict the tenant and raise the rent, or to scare the tenant away from asking for the maintenance that they are owed in order for the unit to be habitable, saving the landlord large sums of money. The lack of protections for tenants clearly make it so that many landlords feel that they can get away with the type of harassment that I faced, and much worse. The current Covid protections are not enough — landlords did not invent new types of intimidation and harassment to kick people out during Covid, they simply continued to use the ones they had before, on an even more vulnerable populace. This will continue to be a problem forever unless action is taken on it. The city council must pass the Tenant Anti-Harrassment ordinance. I also call on the city council to take action to end all illegal lockouts, which are in themselves harassment. Thank you
