I have lived in an RSO bungalow apartment in Silver Lake for almost 20 years. There have been times throughout my tenancy where I lived with apprehension of the landlords' irrational and emotionally charged unpredictable behaviors. I am a good tenant, abiding, not disruptive, always paying my rent on time, caring for where I live and its environs; however, at times, it got quite upsetting to be threatened with eviction for inquiring about a certain fee that was suddenly attached to my rent bill after years of not appearing there or looking out for a neighbor's wellbeing when she faced some challenging repairs to her place. I had wanted to live peacefully all these years without causing a disturbance so I always tried to tread lightly but even so, I would become a subject to the landlords mood swings. it came as a surprise sometimes to find the landlords beings so volatile. I hadn't realized for years that as an RSO tenant, I have rights and now I'm so appreciative about that.

It's a working relationship, tenant and landlord, each benefiting from the exchange. But when landlords abuse the tenants by harassing, threatening, then they 'lord' over those they are benefiting from and it becomes unequal. This needs to be checked, and tenant's rights protected.

Therefore I urge you to support this measure for all tenants city wide. In a world growing more and more consumptive and greedy, human decency is being scrapped and kicked to the curb in a devastating way. It's time to stand up and stop this tidal wave.
