**COUNCIL FILE 17-1143 COMPREHENSIVE ASSESSMENT / STREETS
WITHDRAWN FROM PUBLIC USE / REINSTATEMENT PROCEDURE**

Honorable Councilmembers:

RECOMMENDATION

1. Direct the Board of Public Works to assist the City Attorney in identifying past City ordinances and other City Council actions that removed streets from public use; and
2. Request the City Attorney to draft an ordinance repealing such City Council actions thereby returning the subject streets to public use.

DISCUSSION

On March 27, 2018, the City Council instructed the Department of Public Works to report back with a comprehensive list of all streets removed from public use by ordinance, including the Council District in which such streets are located; and it included various instructions related to the process of returning streets to public use, the investigation of alternate processes for consideration, and the resources that would be required to bring withdrawn streets up to current City standards.

Multiple ordinances and other City Council actions as far back as the 1930's have withdrawn streets from public use in the City of Los Angeles. In general these ordinances authorize and direct the Board of Public Works to return streets to public use when they are found to be safe and passable. The Board of Public Works adopted a policy recommended by the Bureaus of Engineering and Street Services many years ago that, in essence, required streets to be built out to City standards in determining that the street was safe and passable. However, there are many streets in the hillside



areas that are not withdrawn from public use that do not meet current City standards, which has led to some frustration over streets that are in a condition that is as good or better than adjacent streets that are not withdrawn from public use, but are not in a condition that would meet the standards to return them to public use.



The Bureau of Engineering has records of 374 streets being withdrawn from public use either by ordinance or by other Council action. Investigating these streets and the records of historical permits and construction takes a significant amount of staff time. Our investigations to date have found streets that are now being used by the public even though they are technically withdrawn from public use. The Bureau of Engineering and the Bureau of Street Services believe that a more effective and efficient approach may be to repeal the prior ordinances withdrawing streets from public use and for our Bureaus to work with City Council Offices to address the future appropriate measures for the expected small number of streets that may not be appropriate for public use.

The following table indicates the count of streets withdrawn from public use in the Bureau of Engineering's records. These can be viewed in detail in the attachment.
