CR&A Custom is among only a handful of large-format digital printing and outdoor advertising companies that is minority (Hispanic) and woman-owned.

18. Casey O'Neill, Biocom

Casey works out of Biocom's Los Angeles office and has been assisting the non-profit life science organization with their public policy, STEM (Science, Technology, Engineering and Mathematics) and workforce development initiatives for more than two years. She started working on numerous features, television shows, and documentaries in Chicago. After graduating from Columbia College, Ms. Crenshaw interned with union cameramen, getting her start on films such as "Uncle Buck" and working several features for the late John Hughes before heading west to Los Angeles. In 2017, she returned to her hometown of Detroit, Michigan as an artist in resident, teaching cinematography to advanced media students at Wayne State University. When time allows, Ms. Crenshaw shares skills as an adjunct faculty member for University of Southern California Cinematic Arts program. As a member of the International Cinematographers Guild (IATSE Local 600), she was recently re-elected to the National Executive Board.

His responsibilities include contract enforcement, grievance handling, as well as membership engagement, coordinating field campaigns and fundraising. Mr. Edwards has a bachelor's degree in political science and public affairs from Indiana University.

23. Marco Frausto, Reinforcing Ironworkers Local 416

Marco serves as the President of Reinforcing Ironworkers Local 416, which provides trained professional reinforcing ironworkers to commercial, industrial, and residential building contractors throughout Las Vegas, and Los Angeles, Orange, Santa Barbara, San Bernardino, Riverside, and Ventura Counties. Local 416 primarily concentrates on the construction of high rise offices, hotels, low and high rise residential buildings, hospitals, schools, military installations, water treatment plants, solar power plants, fossil fuel power plants, wind power plants, warehouses, mixed use buildings, shopping centers, amusement parks and rides, airports, city halls, civic centers, universities, jails, prisons, piers and heavy industrial plants.

24. Mark Jurisic, International Longshore & Warehouse Union

Mark serves as Business Agent for the International Longshore and Warehouse Union's (ILWU) Local 13. Mr. Jurisic has served as a longshore worker in the ports of Los Angeles and Long Beach since 1998 and has served ILWU in numerous capacities including ILWU's convention Chairman (2012) and serving on the Local 13 Executive Board for eight consecutive years. Mr. Jurisic also served 15 years as a Deputy Sheriff with the Ventura County Sheriff's department. He was awarded the Medal of Valor for entering a burning building in order to save an unconscious citizen, carrying the victim to safety, and saving his life. In 2012, Mr. Jurisic was also awarded a Hero Award by the Los Angeles Police Department for administering CPR on a pedestrian car-accident victim in San Pedro.

25. Luther Medina, Sheet Metal Workers Local 105

Luther is the President and Business Agent for the Sheet Metal Workers International Association (SMWIA) Local 105. Mr. Medina began his career in the unionized sheet metal industry in 1987 and has worked in the capacity of journeyworker and foreperson for several of the union's signatory contractors, both in the heating, ventilation, and air conditioning (HVAC) and general/architectural sheet metal industries. Mr. Medina holds a Bachelor of Arts degree in labor studies from the National Labor College at the George Meany Center for Labor Studies in Silver Spring, Maryland. He is also proud to be a second generation union sheet metal worker.

26. Sergio Rascon, Laborers Union Local 300

Sergio currently serves as the Business Manager for the Laborers Union Local 300. In 1989 he was elected to the Executive Board of Local 300 and soon began his ascendancy through the ranks of Local 300. He has served as the Business Manager and President of Local 300 since 1995. Mr. Rascón served on the Metropolitan Water District's (MWD) Board of Directors from 1997 to 2001. While serving as a MWD Board Member, he held the positions of Vice-Chair of the Subcommittee on Organization and Personnel, served on the Budget and Finance Committee as well as the Legal Claims Committee. Mr. Rascón also served as a Los Angeles City Commissioner on the Convention and Exhibition Center Bureau from 2002 to 2005. Mr. Rascón currently serves on the National Executive Board of the Latin American Council for Labor Advancement as a National Vice President. He also serves as a delegate to the California Consumer Federation, the California Federation of Labor, and the A. Philip Randolph Institute, and as a representative on the L.A. County Federation of Labor Executive Committee on Political Education (COPE) Board.

27. Alexandra Suh, Koreatown Immigrant Workers Alliance (KIWA)

Alexandra is Executive Director of KIWA (Koreatown Immigrant Workers Alliance). She also serves on the Executive Board of the LA County Federation of Labor and on the Board of Directors of the National Immigration Law Center (NILC). Ms. Suh joined KIWA's staff in 2009 and began as director in 2011. KIWA is a multiracial worker center in Los Angeles. Founded in 1992, KIWA's mission is to build the power of immigrant workers and residents, and to organize a progressive grassroots leadership to transform our workplaces and communities in Los Angeles and beyond. Her past experience includes community organizing and advocacy around women workers, peace and trade justice, and immigrant women facing homelessness, prostitution, mental illness, and substance abuse. Ms. Suh holds a Ph.D. from Columbia University and also took courses in

regenerative studies at Cal Poly Pomona with the aim of integrating environmental solutions with social and economic justice work. She was formerly a professor at Scripps College, The Claremont Colleges.

28. Jennifer Kropke, IBEW Local Union 11

Jennifer is the Director of Workforce and Environmental Engagement at IBEW Local Union 11. She was the Vice-Chair of the Los Angeles Metropolitan Transit Agency, Sustainability Council in 2019 where she was elected to help advise the Sustainability Council on the development of sustainability goals in climate action adaptation, green procurement, as well as energy utilization, efficiency, and resiliency.

29. Llanet Martin, Los Angeles Pierce College

Dr. Martin has more than ten years of experience in academia as a Graduate Fellow, Mentor, Residential Advisor, Researcher, Admissions Officer, and Instructor. She includes among her many accomplishments and skill sets developing and implementing curricula, securing funding for special programming, assisting minority and parenting students in preparing for graduate school, and evaluating and synthesizing data to publish scholarly reports that inform education decision-makers. In her current capacity as Student Success and Support Services Coordinator with the Los Angeles Community College District, Dr. Martin oversees a number of initiatives to ensure that students successfully complete their community college studies. Dr. Martin is a member of the Advance Democratic Club, Executive Latino Leadership Association, and UCLA Latino Alumni Association.

The DACE provides learning opportunities and employment training to adults and in-school and out-of-school teens through ten schools and career training centers throughout the Los Angeles area. Annually, DACE serves approximately 89,000 students through a \$155 million budget. Prior to his appointment in 2016, Mr. Stark served as DACE's Division Administrator, joining LAUSD in 2014. From 2008-2014, he was the Director of Adult Education for the Burbank Unified School District. Mr. Stark received his Bachelor of Arts and Master of Arts in school administration from Loyola Marymount University and his Adult Education Teaching Credential from University of California, Los Angeles.

31. Adriene "Alex" Davis, LA/OC Regional Consortium

Alex is the assistant vice chancellor of Economic and Workforce Development in the Educational Services division at Rancho Santiago Community College District (RSCCD) and serves as the executive director for the Los Angeles / Orange County Regional Consortium (LAOCRC) of all community colleges. She is one of the leading economic and workforce development practitioners in the State of California and served as an Instructional Dean of Academic Affairs at Los Angeles City College for 10 years.
