Communication Services - Transfer of Appropriations Between Funds in the Department of Recreation and Parks and the Information Technology Agency.

Recommendation for Mayor and Council Action:

The Board of Recreation and Park Commissioners (Board) respectfully requests Mayor and City Council approval for the Department of Recreation and Parks (RAP) to allow the transfer of appropriations from RAP to Information Technology Agency (ITA), as further detailed in attached Report No. 20-150.

Background:

RAP staff recommends the transfer of appropriations in the amount of One Hundred Fifty Thousand Dollars (\$150,000.00) from RAP to ITA for communication services ITA provides to RAP in Fiscal Year 2020-21. This transfer of appropriations would allow ITA to provide various communication services to RAP as the need arises and without delay. RAP will reimburse ITA for the communication services provided in cash and up to the appropriated amount (\$150,000.00), when proper documentation is received.

Fiscal Impact Statement:

The appropriation and transfer of funds authorized under this Report will have no negative impact on RAP's General Fund.
