It is currently scheduled for a full Council vote on November 24th. This motion does not provide any new housing resources, wrap-around services for those experiencing homelessness, or any solutions to decrease the unhoused population in LA. Instead of focusing on actual, proven solutions to a crisis that continues to grow during this pandemic, City Council members have decided to once again spend time and city resources on another attempt to expand harmful criminalization policies which have only proven to fail and exacerbate homelessness. I demand that City Council and the Mayor's office instead invest their time and legislative power into programs that actually help us move forward in providing a healthy and safe living environments for our unhoused communities while they are on the streets, and take concrete action steps in providing transitional/permanent housing opportunities that meet a higher standard of living than current shelter and ABH facilities offer.

Comments for Public Posting: We have lived in Venice for over 45 years and in the last few years many of our neighborhoods, streets and even the beach have been taken over by transients. Many of these transients are from out of the area because Los Angeles has abandoned all expectations that sidewalks will not be blocked and tents will come down during the day. The population in Venice largely consists of able bodied males between the ages of 20 and 45 who support themselves by stealing bikes and selling drugs. Venice has numerous extremely large encampments that are surrounded by trash. Our streets have been taken over by RVs that store items on the street and often dump their waste in to the gutter. Some transients have put up plywood structures that completely block ADA access to sidewalks and are basically small sheds that are used for living or for storing stolen bicycles. The city knows that 2/3 of the people living on city streets/public right of ways are mentally ill, have substance abuse issues or both. It is unrealistic to expect individuals who have these issues to ensure that the area in and around their encampment is sanitary. Untreated waste and trash ends up on our beach and in the ocean. There are no excuses for the City to allow this to continue. It is not criminalizing the "unhoused" to sanitize and remove trash from the encampments unless this City wants to argue that being filthy and living in filth is a legal right. Regularly scheduled cleanups are not "sweeps" when plenty of advanced notice is given and services are brought in during the cleanup. We have listened to the rhetoric of those opposed to this ordinance and simply cannot understand why they would not want to at least have the city provide basic services such as sanitation to transients. Please remember that the majority of Los Angelenos are not living on the street. Most of your constituents do not throw our trash out on to the street, store bodily fluids out in the open, openly use and sell drugs in public, masturbate in public, verbally harass passerbys, run bicycle chop shops on public property and block the sidewalks forcing disabled, elderly and children in strollers out in to the traffic.
