Comments for Public Posting: I vehemently oppose the closure, as well as an hybrid models, for West Valley Animal Shelter. This is a municipal shelter built by tax payers, in fact, the public is STILL paying on bond (prop F) that paid for this shelter. The valley is over 40% of the city, and the intake of animals at East and West Valley are 42% of the total. So the population correlates to animal intakes. West Valley Shelter is a beautiful newer shelter, and the ONLY shelter with Air Conditioning for outside dog kennels, and as some of you may be aware, we have record breaking heat in the valley. This past weekend, the valley clocked in at over 115 degrees and it is negligent and half witted to leave an air condition shelter sitting empty, only to be given away to private organization to cure racism. Contrary to what Ms. Barnette states in her proposal, giving away an animal shelter does not resolve systemic racism. West Valley was the shelter with third highest intake out of 6 shelters, so it is NOT a small shelter (as falsely represented by Ms Barnette during community zoom meetings). It is an very important and a much needed resource for our community and the animals. This shelter operated at 90% capacity as a FULL MUNICIPAL shelter, and certain months of the year, at over 100% capacity with dogs kenneled in grooming room and hallways. We need this shelter to remain a full municipal shelter, because that is how it was presented and charged to us tax payers. Anything else is defrauding voters and tax payers. East Valley cannot absorb the entire region of the SFV, especially when Porter Ranch residents need a place for their animals during fire season. Constituents of SFV will be grossly under-served and over taxed. The public needs ALL the kennel space we currently have, and at times, even that is not enough. To give away much needed kennel space is liking throwing away your winter coat at the first chill of autumn. Irresponsible management that lacks foresight. Makes zero fiscal sense and is clear case of negligent mismanagement. This department is top heavy and over-bloated. Over the last few years, there has been no change in the # of staff that directly deals with animals (the boots on the ground). All the changes were the additions of top salaried upper management and redundant director positions (1.8 million in UPPER management staff that rarely sets foot inside a shelter or positions filled with no relevant background. For example, Ms. Ramirez. If we want to look into

cuts, that would be the judicious place to look. It makes zero sense why Ms. Barnette was given special permission to hire a second assistant, when the rest of dept is under hiring freeze. To give away public land for free to private organizations is defrauding the tax payers that built this shelter and continue to fund this department. The general manager has failed to look at any other options, and simply wants to push this corrupt deal thru. Once her secret proposal to solve systemic racism by giving away a public shelter was ridiculed publicly, she clung to the notion of possible budget cuts. I urge any an all council members to vote AGAINST such hybrid proposals from Ms. Barnette and reopen West Valley Animal shelter as it was, a full and much needed municipal shelter. To reopen it the way it was presented to the public when the voted for Prop F. While attending the Neighborhood Alliance Council in August of 2020, the mayor incorrectly stated that by giving away West Valley shelter, he would be "expanding" on the services offered. However, that is simply not correct. Those services were already offered, and he just didn't know. There is nothing to gain, but everything to lose. The community is against this hybrid idea. Please feel free to listen to the recorded meetings from staff, volunteers, public...., or check with various neighborhood councils to get a feel of public's sentiments on corruption from Ms. Barnette's office. The lack of response from members of PAWS committee members and Mayor's office is alarming. In particular Mr. Koretz who is chair. Where you Mr. Koretz? the public is about to lose a resource they fund, from a department that answers to you. You are supposed to answer to tax payers and all modes of contacting your office have been ignored. I understand you have goals of running for controller, but it is probably best to at least serve your current position before eyeing the next one.

To quote part of his motion: "The City would be negligent in their obligation to provide necessary services to all stray or lost animals if the West Valley shelter no longer operates as a city shelter and the burden to accommodate and care for an estimated 24,000 animals is left to only the East Valley shelter." This shelter was paid by taxpayers for taxpayers in the valley community to benefit from. It should remain open so Los Angeles residents (especially from the SFV) could benefit from the services. It appears to me that, overall, LA Animal Services is being mismanaged. Brenda Barnette's proposal to make the West Valley Shelter a "hybrid" facility at the expense of taxpayers is a terrible idea. My understanding is that taxpayers would still pay for utilities and possibly insurance for one or two private rescue organizations to use the facility at somewhat their discretion. Even though she has cited a lack of funds to keep the shelter open, it is my understanding that she is proposing a second general manager animal regulation position which would receive a combined package of payment and benefits of over \$225,000. She also could have had the foresight (that is part of what those people in highly paid management positions are paid for) to have opened the West Valley facility early this summer (even if she had to close the East Valley facility temporarily) since the West Valley is the only one of the two with air conditioning. We have had several heat waves with triple digit temps over the summer during which animals suffered. Ms. Barnette's argument (as recorded in a phone conversation) is that in 10 years she has never known a dog to become sick from the heat or to become overheated because they are in those [East Valley dog runs]. But that's not the point! That's going against the spirit and intended mission of an animal shelter at a major city in a first world country. The shelter was sitting there UNUSED the whole summer! A good manager would have been able to orchestrate a move from the East to the West Valley facility, even during a pandemic. That's what she gets paid for. To figure those things out and manage to make it work. We need better leadership.
