BACKGROUND

Los Angeles Municipal Code Section 80.77.4(B)(5) states that "each OPG contract awarded pursuant to this section shall provide for an option to renew the contract for an additional five-year period subject to approval by the City Council."

DISCUSSION

The Commanding Officer of Commission Investigation Division (CID) has conducted a review of all OPGs eligible for renewal.

The Commanding Officer has determined that each of the OPGs in Table A has satisfactorily performed the work required by the contract in compliance with federal, state and local laws.

A review of the complaint history for each of the OPGs listed in Table A revealed no serious violations or patterns of misconduct.

The Commanding Officer of CID conducted interviews with Service Area Commanding Officers and representatives of the Department of Transportation, and Parking Enforcement Bureau regarding the performance of each respective OPG. All of the interviews were favorable and in support of renewal.

CONCLUSION

The Executive Director recommends that the Official Police Garages Towing and Storage Agreements be renewed for the periods set forth in Table A.
