**SUMMARY**

The FY2020 Assistance to Firefighters Grant – COVID-19 Supplemental (AFG-S) Program provides funding for Personal Protective Equipment (PPE) to increase the safety of firefighting personnel and protect the public during the COVID-19 pandemic. The Los Angeles Fire Department (LAFD) submitted an application under the grant to procure Personal Protective Equipment (PPEs) – specifically, eye protection, isolation gowns, coveralls, gloves, respirators, and surgical type face masks - to be used immediately by its members who are on the frontlines of the COVID-19 pandemic. LAFD members are required to don PPEs for each COVID-19 patient that the members encounter; and the members must provide the patient with a surgical type face mask; thus, the LAFD’s PPE burn rate is significant.

On July 24, 2020, the Federal Emergency Management Agency (FEMA) notified the LAFD of an award of funds from the FY2020 AFG-S Program to purchase PPEs. The total approved budget for the PPEs is \$998,880.44. FEMA will fund \$868,591.69 on a reimbursement basis. The LAFD cost share amount of \$130,288.75 will be absorbed by the LAFD 006020 account. The grant performance period for the FY2020 AFG-S program is July 20, 2020 through July 19, 2021.

**RECOMMENDATIONS**

That the Board:

1. Forward to the Mayor for approval, acceptance and authority to expend the FY2020 Assistance to Firefighters Grant Program – COVID-19 Supplemental funding for the procurement of Personal Protective Equipment (PPE).
  
2. Request that the City Council:
  - a. Accept the FY2020 Assistance to Firefighters Grant Program – COVID-19 Supplemental (AFG-S) funding in the amount up to \$868,591.69 for the performance period of July 20, 2020 through July 19, 2021 and any extension of the performance period granted by the Federal Emergency Management Agency (FEMA), and authorize the Fire Chief, or designee, to execute any documents or agreements necessary to accept the grant on the City's behalf.
  
  - b. Authorize the Fire Chief to expend funds in the amount up to \$998,880.44 from the Fire Department's Fund 100, Department 38, Account 006020 for the purchase of Personal Protective Equipment in accordance with the FY2020 AFG-S award.
  
  - c. Authorize the Fire Department to deposit FY2020 AFG-S fund reimbursements into Fund 335, Department 38, Account to be determined.
  
  - d. Authorize the Controller to transfer up to \$868,591.69 from Fund 335, Department 38, Account to be determined to Fund 100, Department 38, Account 006020 upon submission of proper documentation by the Fire Department of expenses incurred during the grant performance period.
  
  - e. Authorize the Controller to transfer \$130,288.75 from Fund 100, Department 38, Account 1012, Salaries Sworn, to Fund 100, Department 38, Account 006020, Operating Supplies, to support the City's match requirement for the grant.
  
  - f. Authorize the LAFD to prepare Controller instructions for any technical adjustments, subject to the approval of the CAO, and authorize and instruct the Controller to implement the instructions.

**FISCAL IMPACT**

The LAFD FY2020-21 General Fund budget will front-fund the expenditure of up to \$998,880.44 associated with the FY2020 Assistance to Firefighters Grant – COVID-19 Supplemental Program. FEMA will reimburse the LAFD up to a total of \$868,591.69; the required cost share of up to \$130,288.75 will be absorbed by the LAFD Account 006020.

**Article 1 Assurances, Administrative Requirements, Cost Principles, Representations and Certifications**

The prohibition on disability discrimination includes the requirement that new multifamily housing with four or more dwelling units—i.e., the public and common use areas and individual apartment units (all units in buildings with elevators and ground-floor units in buildings without elevators)—be designed and constructed with certain accessible features. (See 24 C.F.R. Part 100, Subpart D.)

**Article 10 Copyright**

Recipients must affix the applicable copyright notices of 17 U.S.C. §§ 401 or 402 and an acknowledgement of U.S. Government sponsorship (including the award number) to any work first produced under federal financial assistance awards.

**Article 11 Debarment and Suspension**

Recipients are subject to the non-procurement debarment and suspension regulations implementing Executive Orders (E.O.) 12549 and 12689, which are at 2 C.F.R. Part 180 as adopted by DHS at 2 C.F.R. Part 3000. These regulations restrict federal financial assistance awards, subawards, and contracts with certain parties that are debarred, suspended, or otherwise excluded from or ineligible for participation in federal assistance programs or activities.

**Article 12 Drug-Free Workplace Regulations**

Recipients must comply with drug-free workplace requirements in Subpart B (or Subpart C, if the recipient is an individual) of 2 C.F.R. Part 3001, which adopts the Government-wide implementation (2 C.F.R. Part 182) of Sec. 5152-5158 of the Drug-Free Workplace Act of 1988 (41 U.S.C. §§ 8101-8106).

However, these prohibitions would not preclude recipients from shifting costs that are allowable under two or more awards in accordance with existing federal statutes, regulations, or the federal financial assistance award terms and conditions.

**Article 14 Education Amendments of 1972 (Equal Opportunity in Education Act) – Title IX**

Recipients must comply with the requirements of Title IX of the Education Amendments of 1972, Pub. L. No. 92-318 (1972) (codified as amended at 20 U.S.C. § 1681 et seq.), which provide that no person in the United States will, on the basis of sex, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any educational program or activity receiving federal financial assistance. DHS implementing regulations are codified at 6 C.F.R. Part 17 and 44 C.F.R. Part 19.

**Article 15 Energy Policy and Conservation Act**

Recipients must comply with the requirements of the Energy Policy and Conservation Act, Pub. L. No. 94- 163 (1975) (codified as amended at 42 U.S.C. § 6201 et seq.), which contain policies relating to energy efficiency that are defined in the state energy conservation plan issued in compliance with this Act.

**Article 20 Hotel and Motel Fire Safety Act of 1990**

In accordance with Section 6 of the Hotel and Motel Fire Safety Act of 1990, 15 U.S.C. § 2225a, recipients must ensure that all conference, meeting, convention, or training space funded in whole or in part with federal funds complies with the fire prevention and control guidelines of the Federal Fire Prevention and Control Act of 1974, (codified as amended at 15 U.S.C. § 2225.)

<b>Article 24</b>	<p><b>Nondiscrimination in Matters Pertaining to Faith-Based Organizations</b>  It is DHS policy to ensure the equal treatment of faith-based organizations in social service programs administered or supported by DHS or its component agencies, enabling those organizations to participate in providing important social services to beneficiaries. Recipients must comply with the equal treatment policies and requirements contained in 6 C.F.R. Part 19 and other applicable statutes, regulations, and guidance governing the participations of faith-based organizations in individual DHS programs.</p>
<b>Article 25</b>	<p><b>Non-supplanting Requirement</b>  Recipients receiving federal financial assistance awards made under programs that prohibit supplanting by law must ensure that federal funds do not replace (supplant) funds that have been budgeted for the same purpose through non-federal sources.</p>
<b>Article 26</b>	<p><b>Notice of Funding Opportunity Requirements</b>  All the instructions, guidance, limitations, and other conditions set forth in the Notice of Funding Opportunity (NOFO) for this program are incorporated here by reference in the award terms and conditions. All recipients must comply with any such requirements set forth in the program NOFO.</p>

**Article 27 Patents and Intellectual Property Rights**

Recipients are subject to the Bayh-Dole Act, 35 U.S.C. § 200 et seq, unless otherwise provided by law. Recipients are subject to the specific requirements governing the development, reporting, and disposition of rights to inventions and patents resulting from federal financial assistance awards located at 37 C.F.R. Part 401 and the standard patent rights clause located at 37 C.F.R. § 401.14.

**Article 28 Procurement of Recovered Materials**

States, political subdivisions of states, and their contractors must comply with Section 6002 of the Solid Waste Disposal Act, Pub. L. No. 89-272 (1965), (codified as amended by the Resource Conservation and Recovery Act, 42 U.S.C. § 6962.) The requirements of Section 6002 include procuring only items designated in guidelines of the Environmental Protection Agency (EPA) at 40 C.F.R. Part 247 that contain the highest percentage of recovered materials practicable, consistent with maintaining a satisfactory level of competition.

**Article 29 Rehabilitation Act of 1973**

Recipients must comply with the requirements of Section 504 of the Rehabilitation Act of 1973, Pub. L. No. 93-112 (1973), (codified as amended at 29 U.S.C. § 794,) which provides that no otherwise qualified handicapped individuals in the United States will, solely by reason of the handicap, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving federal financial assistance.

**Article 30 Reporting of Matters Related to Recipient Integrity and Performance**
