In accordance with the Los Angeles Administrative Code, Section 5.182 and as the designated head of Los Angeles Housing and Community Investment Department (HCIDLA) Administration Bureau, I hereby submit for your consideration this report on accounts that are recommended to be written off for the quarter ended, December 31, 2018 based on the following criteria:

- The amounts are uncollectible;
- The write-off will not prejudice the position of the City;
- All reasonable collection efforts have been exhausted;
- The debtor cannot be located or discharge of bankruptcy has occurred; and
- The applicable statute of limitations for collection of debt has expired.

The total amount requested to be written off is **\$ 149,957.00** consisting of 158 invoices covering 22 owners of 35 property (APNs) accounts. Enclosed is a summary list of the accounts receivables for write off with amounts more than \$5,000 per owner, per property.
