2.1(f)(viii) – The Bid Committee was incorporated on August 12, 2014. Prior to August 12, 2014, the activities now conducted by the Bid Committee were conducted by an unincorporated committee-in-formation.

2.1(f)(ix) – Multiple changes to the Bid Budget have been made prior to the date of this Agreement in consultation with the USOC.

2.1(f)(xi) – The Bid Committee has entered into the following Contracts:

- (a) Engagement Letter dated December 4, 2014 between the Bid Committee and Proskauer Rose LLP;
- (b) Fiscal Sponsorship Agreement dated October 17, 2014 between the Bid Committee and Friends of EXPO Center, a California nonprofit public benefit corporation;
- (c) Letter dated October 20, 2014 from the Bid Committee to J. Ben Bourgeois Productions, Inc. re: services to be rendered in connection with October 27, 2014 USOC events; and
- (d) Agreements dated October 7, 2014 and October 20, 2014 between the Bid Committee and 72andSunny Partners LLC.
