## SUMMARY

On September 17, 2018, the Federal Emergency Management Agency (FEMA) notified the Los Angeles Fire Department (LAFD) of an award of funds from the Fiscal Year 2018 (FY 2018) Port Security Grant Program (PSGP) for Marine Firefighter Training. The FY 2018 PSGP will provide a total of \$235,345 in funding for the backfill of staff on overtime, course tuition, and training-related consumables for the specified training course. The FY 2018 PSGP is a cost-share reimbursement grant. The Federal share of the grant is 75%, with a 25% cost match provided by the LAFD. The Federal cost-share is \$176,509 and the LAFD cost-share is \$58,836. The performance period for the FY 2018 PSGP is September 1, 2018 through August 31, 2021.

The purpose of the PSGP funding is to support the U. S. Department of Homeland Security's National Preparedness Goal of "a secure and resilient Nation with the capabilities required across the whole community to prevent, protect against, mitigate, respond to, and recover from the threats and hazards that pose the greatest risk." The five core capability mission areas above will strengthen the nation's critical maritime infrastructure against risks associated events such as natural disasters, disease pandemics, chemical spills and other manmade hazards, terrorist attacks and cyber-attacks. The FY 2018 PSGP will fund Marine Firefighter 1 and 2 training courses and related training exercises. Authority is being requested to negotiate and execute a contract with a vendor to conduct the training courses provided to LAFD members and our regional port partners.

## **RECOMMENDATIONS**

That the Board:

1. Authorize the Fire Chief or his designee, to accept the FY 2018 Port Security Grant Program funding award from the Federal Emergency Management Agency;
2. Approve and transmit this report to the Mayor and City Council for award acceptance and authority to expend FY 2018 Port Security Grant Program funding for Marine Firefighter Training to fund staffing (backfill/overtime), course tuition, and training-related consumables;
3. Request that the Mayor and City Council:
  - a. Authorize the Fire Chief or his designee to expend funds in the amount up to \$235,345 from LAFD Special Training Fund 40J, Account 3840JB in accordance with the FY 2018 PSGP award, from the Federal Emergency Management Agency (FEMA), for the performance period of September 1, 2018, through to August 31, 2021, and any extension of the performance period granted by FEMA;
  - b. Authorize the Controller to deposit reimbursement grant funds into Fund 335, Department 38, Account TBD;
  - c. Authorize the execution of a contract with a vendor to conduct Marine Firefighter Training courses within the grant performance period in an amount not to exceed \$111,000;
  - d. Authorize the Controller to transfer reimbursement grant funds from Fund 335, Department 38, Account TBD to LAFD Special Training Fund 40J, Account 3840JB;
  - e. Authorize the Controller to transfer funds from LAFD Special Training Fund 40J, Account 3840JB to General Fund 100, Department 38, Account 001098 Variable Staffing Overtime for staffing backfill/overtime; Account 003040 Contractual Services for course tuition; and Account 006020 Operating Supplies for training-related consumables, upon submission of proper documentation by LAFD of actual costs incurred from the Advanced Marine Firefighting Training Courses, subject to the review and approval of the City Administrative Officer (CAO); and,
  - f. Authorize the LAFD to prepare Controller instructions for any technical adjustments, subject to the approval of the CAO, and authorize the Controller to implement the instructions.

## **FISCAL IMPACT**

There is no impact to the General Fund. The LAFD will fund the grant-related expenditures of \$235,345 through the LAFD Special Training Fund 40J, Account

3840JB. The FEMA will reimburse LAFD the required cost share of \$176,509 (75%). The remaining LAFD cost share amount of \$58,836 (25%) will be absorbed by the LAFD Special Training Fund.

### **Article I - Summary Description of Project**

Project 3: Marine Firefighter I & II Training and Exercise (DHS-NJ-011-RESP) is fully funded for \$176,509.


