AMENDMENT NO. 1 - MEMORANDUM OF UNDERSTANDING NO. 24 Subject: POLICE OFFICERS, LIEUTENANT AND BELOW BARGAINING UNIT

In accordance with instructions from the Executive Employee Relations Committee (EERC), the City Administrative Officer has negotiated an amendment to the Memorandum of Understanding (MOU) between the City and the Los Angeles Police Protective League (LAPPL) for the Police Officers, Lieutenant and Below bargaining unit. The attached amendment adds a salary note to Appendix I, paragraph D, of the 2011-20014 MOU to provide an enhanced bonus to officers assigned to the Bomb Detection K-9 Section.

The Bomb Detection K-9 Section is deployed at Los Angeles International Airport (LAX), but has citywide responsibilities for performing bomb sweeps and responding to reports of suspicious packages and vehicles. The Section consists of 17 sworn officers at the rank of Police Officer III, Sergeant II, and Lieutenant II. These officers currently receive a one-level bonus of approximately 5.5% which is equal to the bonus received by other Los Angeles Police Department (LAPD) K-9 handlers. In accordance with the negotiated MOU amendment, effective January 1, 2012, they will receive a three-level bonus of approximately 16.5% which is equal to the bonus received by the members of the Bomb Squad. Both the Bomb Squad and the Bomb Detection K-9 Section are part of the LAPD's Emergency Services Division, and members of these two Sections are frequently called out to respond to the same incidents and face similar hazards.

#### RECOMMENDATION

It is recommended that the City Council approve Amendment No. 1 to the 2011-2014 MOU between the City and the LAPPL to provide a three-level bonus to members of the Bomb Detection K-9 Section effective January 1, 2012.

## **FISCAL IMPACT**

There is no increased cost to the General Fund for the increased bonuses of approximately \$180,000 annually as the City is fully reimbursed for the personnel costs for members of the Bomb Detection K-9 Section by the Los Angeles World Airports (LAWA). LAWA is in turn reimbursed for a portion of these costs by the Traffic Safety Administration.

(20) A Police Officer III, when assigned as a Dog Handler at Narcotics Division or, Metropolitan Division or LAX shall be compensated at the corresponding step of Schedule 5.

Item (25) is added as follows to provide specific compensation for officers assigned to the Bomb Detection K-9 Section:

# (25) Any member, when assigned to the Bomb Detection K-9 Section, shall be compensated at the corresponding step of the third schedule above the schedule for their class and pay grade.
