Summary: Please find a document attached on behalf of the Silver Lake Neighborhood Council supporting this motion. Thank you.

The Green Committee requests that the SLNC file a Community Impact (CIS) in SUPPORT of Councilmember Koretz's motion to limit vehicle idling, council file 19-0604.

Summary: The Silver Lake Neighborhood Council, representing more than 45,000 resident stakeholders, supports Councilmember Paul Koretz's motion to ban Car idling. It is necessary to address the issues of poor air quality in Los Angeles due to the increasing concern over the climate emergency. At least 7 states and many cities have already implemented a car idling ban. NYC has had one of the strongest all-vehicle parking idling laws for decades. We are in support of adopting the best practices from these places. Research has consistently found that it is less polluting and more fuel efficient to turn off a modern, fuel-injected vehicle than let it idle for more than 10 seconds long. The SLNC calls on LA City Council to support the Los Angeles Koretz idling ban and post "Clean Air Zone- No Idling Allowed" signs in sensitive areas.

Green Committee Vote: MOTION PASSED. UNANIMOUS 9-0-0.

Summary: The SLNC Green Committee discussed whether modern engines do or do not waste gas starting and stopping and car efficiency. The group noted that this has no fine or citation law, but it does require posting of signs in sensitive areas, such as schools and markets with high foot traffic. Ianthe Zevos moved, John Wingler seconded.
