**RE: TRANSMITTAL OF THE CALIFORNIA DEPARTMENT OF EDUCATION SUMMER FOOD
SERVICE PROGRAM FISCAL YEAR 2019-20 GRANT**

Honorable Mayor and Members of the City Council:

SUMMARY

The City of Los Angeles (City) has received notice of a grant award under the 2019-20 Summer Food Service Program (SFSP), California Department of Education (CDE). The CDE 2019-20 SFSP is a non-competitive, reimbursement grant that is provided annually to the City for its free summer lunch program that is conducted citywide at various Department of Recreation and Parks (RAP) sites. RAP requests authority to retroactively accept this grant in the approximate amount of Two Hundred Thirty-Six Thousand Dollars (\$236,000).

The Board of Recreation and Park Commissioners approved the CDE 2019-20 SFSP grant award on April 2, 2020 to provide a grant reimbursement threshold of up to \$800,000. As a result of the Covid-19 Pandemic, the original grant award was reduced from \$800,000 to \$236,000, and the number of serving sites was decreased from 102 to 37. The request for Council approval reflects the adjusted grant award of \$236,000.

Pursuant to the Los Angeles Administrative Code Section 14.6 et seq., RAP is including a copy of the grant application, grant award notification, and the Board of Recreation and Park Commissioners' Board Report No. 20-040, which was approved on April 2, 2020.

The Summer Food Service Program (SFSP) is a federally funded program administered by the California Department of Education (CDE) that reimburses agencies for providing free nutritious



meals to children 18 years of age and younger during the summer months from June through August. The goal of SFSP is to ensure low-income children continue to receive nutritious meals when school is not in session. RAP submits an annual application to the CDE for its Summer Lunch Program that is administered at over 100 sites throughout the City of Los Angeles, and serves an average of 150,000 to 200,000 lunches each summer. RAP has participated in the SFSP since 1975. Currently, in light of the Covid-19 Pandemic, RAP has instituted various changes to the program to ensure a safe and healthy environment for all participants and staff. The changes include social distancing and face mask requirements, the use of safe practices for lunch distribution and for serving Grab and Go lunches for the community children.

FISCAL IMPACT STATEMENT

The projected expenses for RAP's SFSP for 2020 will be approximately \$273,000 and the anticipated reimbursement is \$236,000.00. As a result, the difference of \$37,000 will create a fiscal impact to RAP's General Fund.

RECOMMENDATIONS

1. Approve the submission of a Summer Food Service Program 2019-2020 (SFSP) grant application to the California Department of Education (CDE) for the Department of Recreation and Parks (RAP) Summer Lunch Program in the approximate amount of Eight Hundred Thousand Dollars (\$800,000.00), subject to Mayor and City Council consideration;
2. Direct RAP staff to transmit the grant application to the Mayor, Office of the City Administrative Officer (CAO), Office of the Chief Legislative Analyst (CLA) and to the City Clerk for committee and City Council approval before accepting and receiving the grant award, pursuant to Administrative Code Section 14.6 et seq. as may be amended;
3. Authorize RAP's General Manager to accept and receive the SFSP grant award, if awarded, in the approximate amount of Eight Hundred Thousand Dollars (\$800,000.00) from the CDE for RAP's Summer Lunch Program, subject to the approval of the Mayor and City Council;
4. SUMMARY

The Summer Food Service Program (SFSP) is a federally funded program administered by the California Department of Education (CDE) that reimburses agencies for providing nutritious meals to children 18 years of age and younger. RAP submits an annual application to the CDE for its Summer Lunch Program. The application for the program is due by May 15, 2020.

RAP has participated in the SFSP since 1975. The program provides free lunches at about 100 parks for RAP during the summer months when the Los Angeles Unified School District (LAUSD) schools are not in session. All sites are "drop-in" sites where meals are available to all children in the area. A list of sites is herein included as Attachment 1. Children do not need to apply, meet eligibility requirements, sign up or sign in. The lunches are nutritious and well-balanced meals that must meet Federal meal pattern requirements.

The 2020 SFSP reimbursement rate is \$4.0875 per lunch. An increase in the rate of reimbursement is determined by the United States Department of Agriculture each January. Reimbursements are calculated based on the number of "first" meals (meals served that do not include leftovers or second servings to the same children) with an allowance for second servings to be claimed. During the 2019 summer season, RAP served 176,695 lunches and was reimbursed \$701,037.42, based on the 2019 reimbursement rate of \$3.9675.

LAUSD's Food Service Division has provided healthy lunches for the Summer Lunch Program since the summer of 2014, and will be the provider for summer 2020.

FISCAL IMPACT

Projected expenses for the Summer Lunch Program for 2020 are approximately \$889,000.00. The projected expenses include the cost of lunches, cost of program monitors, and other program costs. The anticipated reimbursement is \$800,000.00. RAP will match the grant in the amount of approximately \$89,000.
