COUNCIL FILE NO. 19-0600-S78: 2019-20 BUDGET: REPORT BACK ON COMPLETED SIDEWALK REPAIRS FOR CITY FACILITIES AND WORK PLAN

The City Council, during its deliberations on the 2019-20 Proposed Budget requested the Bureau of Engineering (ENGINEERING) to report back to the Public Works and Gang Reduction Committee on the number and location of completed sidewalk repair projects adjacent to City facilities, and a work plan for the next three to five years broken down by Council District (C.F. 19-0600-S78).

Since the start of the Willits Settlement Agreement compliance period, July 1, 2017, the Sidewalk Repair Program (SRP) has completed repairs at 51 Council controlled City facility sites through May 2020. As of June 2020, there are 7 City facility sites under construction. The locations are provided in the report attached.

For Fiscal Years 2020-2021, \$3.8 million has been made available for sidewalk repairs adjacent to City facilities, of which \$ 0.9 million will not be available to January 1, 2021 subject to receipt of SB-1 funds. The attached projected work plan provides a breakdown by Council District assuming funding for repairs adjacent to City facilities remains constant at \$3.8 million per year, for FY 20/21 through FY 23/24, and is based on the Council adopted Sidewalk Repair Program Prioritization and Scoring System (Council File 14-0163-S3). The annual work plan will be subject to field assessment, pre-design and planning coordination.
