RESOLUTION NO. 19-9529 – PROPOSED AWARD AND APPROVAL OF CONTRACT CONSULTANTS: ARCADIS, BERG & ASSOCIATES, DHS CONSULTING, AN ANSER ADVISORY COMPANY, HARRIS & ASSOCIATES, AND INTEGRATED ENGINEERING MANAGEMENT FOR ON-

CALL CONSTRUCTION MANAGEMENT SERVICES

Pursuant to Section 373 of the City Charter and Section 10.5 of the Los Angeles Administrative Code, enclosed for your approval is Resolution No. 19-9529 authorizing the following proposed Agreements between the City of Los Angeles Harbor Department and Arcadis U.S., Inc. (Agreement No. 19-3678); Berg & Associates, Inc. (Agreement No. 19-3679); DHS Consulting LLC, An Anser Advisory Company (Agreement No. 19-3680); Harris & Associates, Inc. (Agreement No. 19-3681); and Integrated Engineering Management (Agreement No. 19-3682); which was approved at the September 5, 2019 meeting of the Board of Harbor Commissioners. The five proposed Agreements are for on-call consultants to provide construction management services for various construction projects throughout the Port of Los Angeles. Services will include construction management, cost estimating, constructability reviews, scheduling and other related construction management services. The on-call consultants will augment the City of Los Angeles Harbor Department Construction Division staff during peaks in the Construction Division's workload, and/or when specialized expertise is required. The number, sizes, and types of projects assigned to the selected consultants will be determined based on the needs of the Construction Division. Each of the five Agreements are for \$2,000,000, with a duration of five years. The total maximum appropriation applicable to the five agreements is \$10,000,000. There is no impact to the General Fund.

RECOMMENDATION FOR CITY COUNCIL:

- ADOPT the determination by the Board of Harbor Commissioners that the proposed action is administratively exempt from the requirements of the California Environmental Quality Act (CEQA) in accordance with Article II, Section 2(f) of the Los Angeles City CEQA Guidelines;
- APPROVE Harbor Department Resolution No. 19-9529 authorizing the following proposed Agreements between the City of Los Angeles Harbor Department and Arcadis U.S., Inc. (Agreement No. 19-3678); Berg & Associates, Inc. (Agreement No. 19-3679); DHS Consulting LLC, An Anser Advisory Company (Agreement No. 19-3680); Harris & Associates, Inc. (Agreement No. 19-3681); and Integrated Engineering Management (Agreement No. 19-3682); and
- Return to the Board of Harbor Commissioners for further processing.
