Comments for Public Posting: This letter is submitted on behalf of the Brentwood Community Council (“BCC”) and South Brentwood Residents Association (“SBRA”), which represents the interests of the owners and residents of multi-family buildings (i.e., townhomes/condominiums and apartments) and small businesses in Brentwood. The BCC and SBRA SUPPORT proposed Ordinance No. 21-0034 (O’Farrell/Price), which was introduced on January 12, 2021 (the “Ordinance”). The Ordinance instructs the Bureau of Sanitation (“LASAN”) and RecycLA Service Providers to report to the City Council in 30 days on their efforts to work with customers who may be impacted by the RecycLA Program’s 6.15% rate increase effective January 2021. The BCC and SBRA further supports any and all efforts and measures to stay the annual price increases imposed by Athens Services (“Athens”) and other RecycLA Service Providers or that would mitigate the impact of such price increases. We believe that a 6.15% rate increase by Athens at this time is highly inappropriate and would impose an unreasonable impact on multi-family residential buildings and small businesses in Brentwood. As you will recall, after the Athens-City of Los Angeles trash hauling contract commenced in June 2016, the rate of County Health Department refuse-related violations in South Brentwood skyrocketed. In 2017-2018, there were 198 violations in South Brentwood. At the same time, Athens implemented an exorbitant increase in the prices they were charged to multi-family residential and commercial buildings in Brentwood. Indeed, such increases were as high as 300% for some buildings, forcing many buildings and businesses to downgrade the level of service which they receive. Those price increases went into effect at the end of 2017 and there have been small annual increases since that time. Since 2019, the number of refuse-related Health Code violations have diminished in South Brentwood but there was no mitigation of Athen’s exorbitant price increase at the end of 2017 except that Athens gave discounts to the buildings which were cited with Health Code violations. Further, the Coronavirus has had a disastrous impact on the income of the owners of condominiums/townhomes and small businesses in Brentwood and they are not in a position to absorb an additional price

increase from Athens. If Athen's prices are increased, such owners will be forced again to downgrade their level of trash-hauling service, leading to the massive increase in Health Code violations we saw take place in 2017 and 2018 when Athen's prices were previously increased. We need to avoid a reoccurrence of such health and safety concerns and hope that the Ordinance will assist in that effort.
