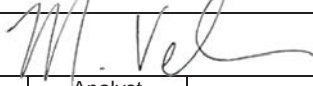

RECOMMENDATION

That the City Council authorize the General Manager of the Information Technology Agency, or his designee, to execute Amendment No. 2 to City Contract C-127521 to a) extend the term of the Contract by 18 months through December 31, 2021; b) increase contract compensation by \$700,000, for a new total not to exceed \$5.7 million; and c) the effectuate the name change of the contractor to Verizon Business Network Services LLC on behalf of and as agent for MCI Communications Services LLC dba Verizon Business Services, subject to the approval of the City Attorney.

SUMMARY

The Information Technology Agency (ITA) requests approval of Amendment No. 2 to Contract C-127521 (Contract) with Verizon Business Network Services LLC (Verizon) for Citywide telecommunications services through the State of California's CALNET 3 Program (CALNET 3). The majority of City facility dedicated transport and hosted interactive voice response/automatic call distributor services costs are funded through this Contract. Recent Contract expenditures have been in support of the Department of Aging's Senior Meals Program, the Housing and Community Investment Department's Emergency Rental Assistance program, the Office of Finance's tax and permit revenue collection, and the Fire Department's Brush Clearance Program. The purpose of Amendment No. 2 is to 1) extend the term of the Contract for 18 months through December 31, 2021; 2) increase the contract

compensation by \$700,000 to \$5.7 million; and 3) effectuate the name change of the contractor from Verizon Business Network Services Inc.

In 2015, the California Department of Technology, Office of Technology Services (CDT) implemented CALNET 3. CALNET 3 provides local jurisdictions within the State of California the ability to use Master Services Agreements (MSA) to obtain discounted volume pricing for telecommunications services that has remained unchanged since CALNET 3's establishment. The original CDT term of CALNET 3 was five years, effective June 1, 2015, including two one-year renewal options. As ITA's Contract must be consistent with the CDT MSA, ITA's original Contract was for a term effective three years through May 31, 2018. After CDT extended the term of the MSA, Amendment No.1 to the Contract was executed in 2018, which extended the term of the Contract through June 30, 2020 (C.F. 18-0902). CDT subsequently extended the term of the MSA through December 31, 2021, and ITA now requests to execute Amendment No. 2 to extend the term of the Contract to that date.

In addition, Verizon notified ITA that effective July 1, 2020 the name of the company changed from Verizon Business Network Services Inc. to Verizon Business Network Services LLC on behalf of and as agent for MCI Communications Services LLC dba Verizon Business Services. ITA reports that the reason this Amendment's processing was delayed was that the Department had to wait for CDT to amend the MSA to reflect the new name and provide proof of the name change to ITA.

Finally, the last remaining substantive change in Amendment No. 2 is the increase in compensation by \$700,000, from \$5 million to \$5.7 million. This increase is requested based on actual current monthly expenditures. Pursuant to the Contract, annual expenditures are limited to no more than \$1,666,666, but actual average annual expenditures have been less than half this amount. Expenditures through the Contract are determined based on actual service usage.

Verizon is not the sole provider of these services under CALNET 3. Other CALNET 3 providers of telecommunications services include AT&T, Electric Lightwave, Jive, NWN, CenturyLink, Comcast, Cox, and Level 3. ITA indicates that Verizon's pricing is competitive. This CALNET 3 contract is not exclusive; the City could and does opt to obtain services from another provider as pricing and services required by City departments dictate. The Council recently authorized an amendment to the City's existing contract with AT&T for similar telecommunications services (C.F. 18-0902).

Charter Section 1022 does not apply as the Contract is with a regulated public utility and there is no defined labor component. Verizon has completed with all applicable City contracting requirements. The Contract is not subject to the Business Inclusion Program, Equal Benefits Ordinance, First Source Hiring Ordinance, or Contractor Responsibility Ordinance because it was entered into pursuant to the CDT MSA, which was competitively bid and provides the City discounted volume pricing. The City Attorney has determined that the standard provisions for City personal services contracts are not required for this Contract due to the nature of the public utility services being procured. In accordance with Los Angeles Administrative Code Section 10.5(b)(2), Council approval of the proposed Amendment is required because the Contract exceeds three years in term and the annual expenditure on the Contract exceeds \$163,016.

The Mayor's Fiscal Year 2020-21 Cost Containment Measures Memorandum dated June 24, 2020, reaffirmed by the Mayor's Fiscal Year 2020-21 Instructions for Fiscal Restraint dated September 11, 2020, directed departments to suspend the execution of new contracts and contract amendments, with limited exceptions for contracts that 1) are essential to public health and safety, 2) generate revenue, or 3) are legally mandated. The services of the Contractor are utilized by various City departments to

provide dedicated call transport and hosted interactive voice response/automatic call distributor services for City services that are essential to public health and safety, revenue generating, and legally mandated. Therefore, the execution of the proposed Amendment No. 2 is eligible for exemption from the direction in these Memoranda.

FISCAL IMPACT STATEMENT

Sufficient funding for 2020-21 anticipated Contract expenditures is available in the Department's Communication Services Account, Fund No. 100, Account No. 009350. Future year expenditures are limited to the availability of funds appropriated in the budget for this purpose.

FINANCIAL POLICIES STATEMENT

The recommendation of this report is in compliance with the City's Financial Policies as budgeted funding is available to support anticipated contract expenditures.

Subject: **AMENDMENT NO. 2 FOR VERIZON BUSINESS NETWORK SERVICES LLC (FORMERLY VERIZON BUSINESS NETWORK SERVICES, INC.) CONTRACT C-127521 FOR CITYWIDE TELECOMMUNICATION SERVICES**

Attached for your review and approval is Amendment No. 2 to the personal services contract between the City of Los Angeles and Verizon Business Network Services LLC (formerly Verizon Business Network Services, Inc.), for citywide telecommunications services. Amendment No. 2 to Contract C-127521 extends the term of the contract for 18 months through December 31, 2021, increases the expenditure limit to Five Million Seven Hundred Thousand Dollars (\$5,700,000.00) and changes the name of the Contractor from Verizon Business Network Services Inc. to Verizon Business Network Services LLC.

BACKGROUND

In 2011, the State of California Technology Agency began efforts to replace the California Integrated Information Network (CALNET 2). Through RFI and RFQ processes, the State announced the award to six companies eligible to participate in the solicitation process. The Office of Technology Services began posting a series of bulletins on available services, forms, pricing catalogs and user instructions for non-State entities who needed to transition or migrate services from CALNET 2 to CALNET 3.

The ITA reviewed each of the pricing catalogs posted by the six CALNET 3 contractors and made the recommendation that contracting with Verizon was deemed in the best interest of the City.

In 2015, the ITA, Verizon, and the State of California ("State") executed an Authorization to Order ("ATO") under the CALNET 3 contract whereby the ITA ordered services for Dedicated Transport, VoIP, SONET and Hosted IVR/ACD,

pursuant to the terms and conditions of CALNET 3, C3-A-13-02-TS-08 Contract A and C3-B-13-02-TS-08 Contract B.

The City and Verizon subsequently entered into contract C-127521 on May 23, 2016, for a three year term, plus two one-year renewal options. In 2018, the State exercised its first option to extend the term of the CALNET 3 contract through June 30, 2019, and once again in 2019 for the second extension through June 30, 2020. The ITA and Verizon opted to accept both term extensions.

The State has since extended the term of the CALNET 3 contract until December 31, 2021. The ITA and Verizon wish to amend the Agreement to extend the term of the contract to December 31, 2021, in accordance with the extension of the State's CALNET 3 term.

The ITA is also requesting to increase the expenditure limit by an additional \$700,000.00, which is based on the average monthly expenditures for the additional 18 months. This will increase the total contract expenditure limit to \$5,700,000.00. Verizon's CALNET 3 pricing has remained the same through the life of the contract.

Verizon notified the ITA that effective July 1, 2020, its registered business name had changed from Verizon Business Network Services Inc., to Verizon Business Network Services LLC, on behalf of and as agent for MCI Communications Services LLC dba Verizon Business Services. The name change will be reflected in this amendment.

Multiple Council Controlled departments utilize the Verizon CALNET contract for their day-to-day operations to support the City's financial and public safety systems. Among those include the LAPD for their call centers, which connect thousands of officers each month from agencies throughout the US with vital records regarding property and criminal investigations. In addition, the Fire Department utilizes this contract to run its Brush Clearance unit to act as a central contact point for tens of thousands of homeowners throughout the City, as they manage vegetation hazards to mitigate the dangers of wildfires throughout the City. The Office of Finance also uses this contract to handle its tax and permit contacts, which number in the thousands per day during their renewal period each year.

The services provided through this contract have been utilized for high priority and critical operations during emergencies, such as the COVID-19 pandemic. The Department of Aging used this contract early last year for the Mayor's Senior Meal program, which received calls at a rate of 1,000 per minute. The Housing and Community Investment Department also used this contract to handle calls for the Council's Emergency Renters Assistance Subsidy program.

LA citizens also benefit from this contract through our 311 services, public counter operations and street services. It is essential to continue this contract for the financial and public safety services provided to the City and its citizens. No new services have been added to this amendment.

Since the scope of work has not changed, the ITA's City Administrative Office Analyst stated that the Charter Section 1022 determination process was not required.

The Contractor's insurance agent has uploaded an ACORD certificate into the Risk Management website in the amounts identified by the City's Risk Manager.

The Contractor uploaded both EBO/FSHO and Disclosure Ordinance affidavits in the LABAVN website, and the documents are pending verification by Public Works Bureau of Contract Administration (BCA).

The vendor possesses a valid Business Tax Registration Certificate.

The draft contract has been reviewed by the City Attorney as to form.

Since the ITA and Verizon executed Contract C-127521 under the terms and conditions of the CALNET 3 contract between Verizon and the State of California Department of Technology, an amendment to the State's contracts reflecting the change in business name was necessary prior to amending the City's contract. The ITA encountered a delay in obtaining proof of the name change with the State of California Department of Technology which prevented processing the contract amendment draft in a timelier manner. The ITA is therefore requesting that the review and approval for this request be expedited since the contractor has continued to provide essential services.

Fiscal Impact

Funding is included in the ITA Communications Services Account (9350) for citywide telecommunications services.

Recommendation

That the Council, subject to the approval of the Mayor, authorize the General Manager of the Information Technology Agency, or his designee, to 1) execute Amendment No. 2 to Contract C-127521 with Verizon to extend the term of the contract through December 31, 2021, 2) increase the total maximum amount of expenditure authorized under the contract by Seven Hundred Thousand Dollars (\$700,000.00), for a maximum expenditure limit of Five Million Seven Hundred Thousand Dollars (\$5,700,000.00), and 3) execute an amendment to implement a name change.

BETWEEN

CITY OF LOS ANGELES

AND

VERIZON BUSINESS NETWORK SERVICES LLC (FORMERLY VERIZON BUSINESS
NETWORK SERVICES INC.)

This Amendment No. 2 ("Amendment") to that certain City of Los Angeles Contract No. C-127521 is made and entered into by and between the City of Los Angeles, a municipal corporation (herein referred to as "City"), acting by and through its Information Technology Agency ("ITA"), and Verizon Business Network Services LLC (formerly Verizon Business Network Services Inc.) on behalf of all service providing Verizon Business Network Services LLC affiliates, including MCI Communications Services LLC d/b/a Verizon Business Services (hereinafter referred to as "Contractor" or "Verizon") providing the products and services, with reference to the following:

WITNESSETH:

WHEREAS, the City of Los Angeles through its ITA is responsible for providing select telecommunication services to all City departments; and

WHEREAS, the State of California's Office of Technology Services awarded agreement C3-A-13-02-TS-08 Contract A and C3-B-13-02-TS-08 Contract B (Exhibit 3 of the Contract (as defined below), also referred to, along with related State agreements, as "CALNET 3") to Contractor for Dedicated Transport, VoIP, SONET and Hosted IVR/ACD Services through a competitive bid process; and

WHEREAS, the State of California's Office of Technology Services allows local governmental agencies to take advantage of beneficial volume pricing through the collective buying power of the whole public sector in the State; and

WHEREAS, the City, Contractor, and the State of California ("State") executed an Authorization to Order ("ATO") under the CALNET 3 contract whereby the City ordered, and the Contractor agreed to provide to the City, select utility services pursuant to the terms and conditions of the CALNET 3 contract; and

WHEREAS, in connection with the ATO, the City and the Contractor entered into that certain City of Los Angeles Contract No. C-127521 having a term commencing June 1, 2015, and ending three (3) years thereafter (the "Contract" or "Agreement") such contract having been approved by City Council (C.F. 18-0902); and

WHEREAS, on December 19, 2018, the City and Contractor entered into that certain First Amendment to Contract C-127521 which, among other things, extended the term of the Contract to June 30, 2019, consistent with the extended term of the CALNET 3 contract, the term of the Agreement being coterminous with the CALNET 3 contract date, and gave the City the option to extend the term of an additional year at the City's sole discretion, should the State extend its CALNET 3 contract; and

WHEREAS, pursuant to the State's extension of the term of the CALNET 3 contract, the City exercised its extension option to be coterminous with the CALNET 3 contract date and extended the term of Contract C-127521 for one additional year to June 30, 2020; and

WHEREAS, the State has extended the term of the CALNET 3 contract an additional 18 months until December 31, 2021; and

WHEREAS, the City and Contractor now desire to amend the Contract to extend the term of the Contract, as previously amended, to extend the term to December 31, 2021, and to increase the total maximum amount of expenditure authorized under the Contract by Seven Hundred Thousand Dollars (\$700,000.00), for a total maximum authorized expenditure amount not to exceed Five Million Seven Hundred Thousand Dollars (\$5,700,000.00); and

WHEREAS, the Contractor changed its name under the CALNET 3 contract to MCI Communications Services LLC d/b/a Verizon Business Services; and

WHEREAS, the Contractor has submitted all required contracting forms in compliance with City ordinances and regulations under the name MCI Communications Services LLC d/b/a Verizon Business Services; and

WHEREAS, the City and Contractor wish to amend the Contract to reflect the above referenced name change;

NOW, THEREFORE, in consideration of the above recitals and of the covenants and agreements hereafter set forth, the City and Contractor hereby covenant and agree that the Agreement is amended effective June 29, 2020, as follows:

- I. The term "Contractor" or "Verizon Business Network Services Inc." in the Contract shall mean and refer "Verizon Business Network Services LLC" on behalf of and as agent for MCI Communications Services LLC dba Verizon Business Services (formerly MCI Communications Services, Inc., MCI metro Access Transmission Services, LLC, and Verizon Select Services, Inc.) (alternately referred hereafter as "Verizon").
- II. **TERM OF CONTRACT:** Section I. is hereby amended in its entirety and restated as follows in quotation marks:

"The term of this Contract shall commence on June 1, 2015, and shall terminate on December 31, 2021, or at such time as all funding provided herein has been expended, whichever occurs first."

- III. **COMPENSATION AND METHOD OF PAYMENT:** The first paragraph of Section III. is hereby amended in its entirety to read as follows below in quotation marks:

"The total expenditure made under this Contract shall not exceed \$1,666,666 (One Million Six Hundred Sixty Six Thousand Six Hundred and Sixty Six dollars) on an annual basis and shall not exceed \$5,700,000.00 (Five Million Seven Hundred Thousand dollars) during the term of this Contract."

- IV. **CONTRACT REPRESENTATIVES:** Section IV.C is hereby amended in its entirety and restated as follows below in quotation marks:

"C. City's Project Manager

The City hereby appoints the following person to act as the Project Manager.

Formal notices, demands and communications from Contractor shall be given to the City's Representative with copies to the City's Project Manager.

Formal notices, demands and communications required hereunder by either party shall be made in writing and may be effected by personal delivery or by registered or certified mail, postage prepaid, return receipt requested and shall be deemed communicated as of the date of mailing.

If the name of the person designated to receive the notices, demands or communications or the address of such person is changed, written notice shall be given, in accordance with this Section, within five (5) working days of said change."

- V. The Contract is amended to include the following paragraph below in quotation marks as Section XI, which shall be entitled **DISCLOSURE OF BORDER WALL CONTRACTING ORDINANCE:**

“Contractor shall comply with Los Angeles Administrative Code Section 10.50 et seq., 'Disclosure of Border Wall Contracting.' City [or the Department, etc.] may terminate this Contract at any time if City [or the Department, etc.] determines that Contractor failed to fully and accurately complete the required affidavit and disclose all Border Wall Bids and Border Wall Contracts, as defined in LAAC Section 10.50.1.”

- VI.** The Contract is amended to include the following paragraph below in quotation marks as Section XII, which shall be entitled **ELECTRONIC SIGNATURES:**

"This Agreement may be executed in one or more counterparts, and by the parties in separate counterparts, each of which when executed shall be deemed to be an original but all of which taken together shall constitute one and the same agreement. The parties further agree that facsimile signatures or signatures scanned into .pdf (or signatures in another electronic format designated by City) and sent by e-mail shall be deemed original signatures."

- VII.** Except as amended herein, all other terms and conditions of the Agreement shall remain in full force and effect.
