CATEGORICAL EXEMPTION and PUBLIC WORKS AND GANG REDUCTION COMMITTEE REPORT relative to the vacation of an alley southerly of Saticoy Street westerly of Van Nuys Boulevard (VAC-E1401213).

Recommendations for Council action:

- 1. FIND that the vacation of an alley southerly of Saticoy Street westerly of Van Nuys Boulevard is exempt from the California Environmental Quality Act of 1970, pursuant to Article III, Class 5(3) of the City's Environmental Guidelines.
- 2. ADOPT the FINDINGS of the City Engineer dated October 3, 2013, as the Findings of Council.
- 3. FIND that the street vacation proceedings pursuant to the Public Streets, Highways and Service Easements Vacation Law be instituted for the vacation of the public right-of-way indicated below and shown colored blue on Exhibit B of the October 3, 2013 City Engineer report, attached to the Council file:

The alley southerly of Saticoy Street westerly of Van Nuys Boulevard and the 5-foot and 2.5-foot drainage easements located within Lot 1 of Tract 19368.

- 4. ADOPT the accompanying City Engineer report dated October 3, 2013 to approve the vacation.
- 5. INSTRUCT the City Clerk to set a public hearing date for **APRIL 23, 2014**.

<u>Fiscal Impact Statement</u>: The City Engineer reports that the petitioner has paid a fee of \$32,100 for the investigation of this request pursuant to Section 7.42 of the Administrative Code. Any deficit fee to recover the cost pursuant to Section 7.44 of the Administrative Code may be required of the petitioner.

Community Impact Statement: None submitted.

SUMMARY

At its regular meeting held on February 19, 2014, the Public Works and Gang Reduction Committee considered the recommendations of the City Engineer as contained in its October 3, 2013 report. The City Engineer reports that the area sought to be vacated is the alley southerly of Saticoy Street westerly of Van Nuys Boulevard and the 5-foot and 2.5-foot drainage easements located within Lot 1 of Tract 19368 (a map of the area is included as Exhibit B in the October 3, 2013 City Engineer report and is attached to the Council file). The purpose of the vacation request is for proposed development at the site. This vacation procedure is being processed under procedures established by Council on March 5, 2002 as detailed in Council file No. 01-1459.
