Upon approval of expenses and receipt of grant funds, transfer up to \$941,588 from Fund No. 368, Account No. 12T643 to Fund No. 100/12, Revenue Source No. 5346 Related Cost Reimbursement from Grants as reimbursement for City Attorney fringe benefits and indirect costs related to the LA DATA project for the period January 1, 2021 to December 31,2023.

a. Transfer \$534,440 from Fund 368, Account 12T643 - LA DATA Program to Fund 100 Department 12, Account 001010 - Salaries General.

b. Transfer \$591,120 from Fund 368, Account 12T643 - LA DATA Program to Fund 100, Department 70, Account 001092 Overtime - Sworn.

c. Transfer \$6,912 from Fund 368, Account 12T643 - LA DATA Program to Fund 100, Department 70, Account 01090 Overtime - Civilian.

8. AUTHORIZE the City Attorney to issue a RFP to develop an online virtual diversion platform.

9. AUTHORIZE the City Attorney to prepare Controller instructions for any necessary technical adjustments, subject to the approval of the City Administrative Officer and instruct the Controller to implement the instructions.
