**RE: APPLICATION FOR PUBLIC CONVENIENCE OR NECESSITY RELATED TO A  
CANNABIS BUSINESS  
COUNCIL FILE NO. 21-0420-S40; CD 2**

Greetings:

The Los Angeles Police Department (LAPD) was recently notified regarding the pending application for a commercial cannabis license at 7235 Clybourn Avenue. Please be advised that the LAPD, North Hollywood Division, is adamantly opposed to the granting of this license at this location.

Factors which were taken into consideration include, but are not limited to, public safety and the availability of LAPD resources. The reasons for the opposition are as follows:

## **Public Safety**

Commercial Cannabis Businesses (CCB) engaging in the retail sale of cannabis and products containing cannabis are "cash-only" entities. These locations are attractive targets for the criminal element, not only for the large amounts of cash they generate, but also for the actual cannabis products that are sold and stored on the premises.

From calendar years 2019, 2020, and 2021 to present, the below number of Robberies, Aggravated Assaults, Burglaries, and Thefts were reported to have taken place at retail CCB locations.

- (3) Robberies
- (3) Aggravated Assaults
- (15) Burglaries
- (1) Theft

Additionally, there were (3) Burglaries and (1) Theft which were reported at non-retail CCBs (e.g. cannabis cultivation sites) during the same time period.

These numbers reflect only those crimes which were reported with the actual numbers undoubtedly being higher.

Such crimes not only place employees and patrons of the CCBs at risk, but the surrounding community as well. Due to the increased propensity for crime, many CCBs have resorted to hiring armed security. Although this step will serve as a deterrent, it will not prevent all criminal acts from occurring at these locations. The need for armed security is self-evident of the elevated risks involved in operating a CCB.

CCBs also place a tremendous burden on the already limited resources of the LAPD. Response to such incidents involves, but is not limited to, dispatching officers to respond to the calls for service, conducting the preliminary and follow-up investigations, collection and processing of evidence, arresting any identified suspect(s), presenting cases for criminal filing to the District or City Attorney's Office, and personnel subpoenaed to testify during court proceedings. This translates into dozens of hours expended for such activities.

### **Resources**

Currently, 184 licensed retail CCBs operate within the City of Los Angeles. The LAPD is divided into 21 geographic divisions within the City. If evenly distributed, each division would have approximately nine (9) licensed retail CCBs. At this time, the North Hollywood Division has 21 licensed retail CCBs which accounts for over 11% of the licensed locations throughout the City of Los Angeles. At approximately 25 square miles, the North Hollywood Division accounts for approximately 5% of the 503 square miles the City of Los Angeles covers. With over 220,000 residents, the area makes up approximately 5% of the total population of the City of Los Angeles (nearly 4 million residents). Either way, the North Hollywood Division encompasses a disproportionate number of licensed retail CCBs at a rate of more than double of what would be expected by area or population.

Aside from resources utilized for criminal investigations, the LAPD will have to devote additional hours to conduct outreach, tracking, and monitoring at licensed retail CCB locations. This comes at a time when the Department faces severe budgetary cuts and the reassignment of personnel to focus on the rising level of violent crime in the City. Adding additional responsibilities will only place an undue burden on the finite resources available to perform these tasks.

An additional basis for this opposition is the over-saturation of existing cannabis licensed locations within the Sherman Oaks-Studio City-Toluca Lake-Cahuenga Pass Community Plan Area (CPA). A review indicates that nine (9) cannabis business premises are allowed within this CPA. Currently, there are 12 existing licensed cannabis business locations, indicating that this particular CPA is beyond its undue concentration limit. The closest licensed retail cannabis

business to the proposed location is located at 10745 Riverside Drive; that is approximately .7 miles away or a two-minute drive. If this license is granted, it places an undue hardship on the community and should be of significant consideration in the justification to deny the license.

Should this license be issued despite our objections, it is reasonable to assume that the licensee will be encouraged to take a proactive role in protecting the welfare of its patronage and the public.

The LAPD invested considerable time and resources to bring about the closure of illegal cannabis businesses throughout the City. The removal of these locations has significantly enhanced the quality of life in the surrounding communities. We would not like to see our efforts be invalidated with the approval of another cannabis location in an area that already is oversaturated with this type of business.

Attached is a printout of Area Crime Analysis showing crimes and calls for service that were generated in the vicinity of this location.


