Our organization supports more housing at all levels of affordability and reforms to land use and zoning codes, which are needed in order to make housing more affordable, improve access to jobs and transit, promote greater environmental sustainability, and advance racial and economic equity.

We write in strong support of the proposed Tenant Anti-Harassment Ordinance. We are concerned about landlords using unscrupulous practices to force their tenants to leave their homes, and we support reforms that will more effectively punish bad actors.

The proposed ordinance offers a critical and long-overdue step towards stronger tenants' rights protections.
