RE: APPLICATION FOR PUBLIC CONVENIENCE OR NECESSITY RELATED TO A
CANNABIS BUSINESS; COUNCIL FILE NO. 21-0420-S13 and 21-0420-S15 – CD 14

Greetings,

The Los Angeles Police Department (LAPD) was recently notified regarding the pending application for a commercial cannabis license at 1051 S. Broadway. Please be advised that the LAPD-Central Area is adamantly opposed to the granting of a license at this location.

Since 2016, LAPD Central Area has been conducting enforcement of illegal cannabis dispensaries in the surrounding area. The most recent enforcement took place in January 2021 at a location less than .5 miles away. Central Area has invested numerous hours and resources to address the issue of illegal cannabis sales and cultivation. With each operation, Central Area has dedicated Narcotic Detectives and uniformed personnel with an average of (15) officers per investigation. Many of our investigations have resulted in the seizures of illegal firearms, Scheduled-1 narcotics, and unlicensed cannabis products. This area of Central Area is highly sought after by the cannabis industry due to the retail commercial businesses that attract thousands of visitors on a daily basis.

Since the onset of cannabis sales, Central Area has seen increased in robberies and assaults with firearms. The most recent assault resulted in a homicide in March of 2021. There are currently (2) additional applicants for commercial cannabis licenses within a few blocks of 1051 S. Broadway Blvd. A detailed analysis of the surrounding area of the proposed commercial cannabis retail location revealed a total of 1,650 calls for service in the past 12-month period. Many of these calls were violent in nature and consisted of robberies and assaults. This area is heavily trafficked, densely populated, and, as mentioned above, has a significantly large number of calls for service.

An additional basis for our opposition to this potential licensing is the over-saturation of existing cannabis locations within the Central City Community Plan Area (CPA). A review indicated that only four cannabis business premises are allowed within this CPA. Currently, there are seven existing licensed retail cannabis locations, indicating that this CPA is beyond its concentration limit.

The closest licensed retail cannabis business to the proposed location is located at 1149 S. Los Angeles St., which is a merely few blocks southeast of the additional proposed location. If the license at 1051 S. Broadway is granted, this will place an undue hardship on the community and should be of significant consideration in justifying a denial of the license. Other important factors to consider is the proximity of the proposed location to two critical sites. 1051 S. Broadway is located within 700 feet of two accredited schools (SIATech Los Angeles- 221 W. 11th Street and Job Corps- 1031 S. Hill Street). Should this license be issued despite our objections, it would be reasonable to expect the licensee to take a proactive role in protecting the welfare of its patrons and the public, which include the young students in the aforementioned schools.

The LAPD has invested considerable time and resources to bring about the closure of illegal cannabis businesses throughout the City and the removal of these locations has significantly enhanced the quality of life in the surrounding communities. We believe the approval of this additional cannabis location would invalidate our efforts to control crimes associated with the proliferation of the cannabis industry, which is already oversaturated in the vicinity.
