Comments for Public Posting: Instead of a park used by tax-paying citizens, why not land that is not used by the public. LA City has over 7000 parcels of land listed as not used as intended and little hope of generating any tax revenue. And don't consider converting a hotel or apartment into a shelter in expensive real estate communities either. Yes, some hotels are struggling now because of Covid, but they will return to become the tax-revenue goose that lays the golden eggs for the city again. Ramada Inn Marina Del Rey on Washington Blvd, Venice, has 33 rooms... If it was run as a hotel estimating a low figure of \$150 per night, 90% occupancy for the year, and 12% hotel tax, that would be approximately \$5913 tax per room per year. Or over \$195,000 in taxes collected for city use. Also, employees of the hotel would be paying state and local income taxes on their salary working for the hotel. Don't forget property taxes the owner would also have to pay the city. We forfeit all of that now by using the valuable real estate property as a shelter instead. Guess how the municipality is going to make up for those lost tax revenue AND guess who is paying to run the shelter?? This is terrible wasteful use of expensive beach area property. Fiscally irresponsible. Don't make similar mistakes with popular parks and beaches.
