Comments for Public Posting: 1. I am a resident of the City of Los Angeles; I vote in every election. 2. I OPPOSE the motion that will allow housing in beach and park parking lots. I am well aware of the difficulty in finding adequate temporary/permanent housing for the unhoused residents of Los Angeles, and acknowledge that it is only getting worse. However, to open the public beach parking lots (Will Rodgers, Marina del Rey, etc.) for use as housing is a complete disservice to the remaining population of the City. As you may recall, it gets overwhelmingly hot during the summer, and these beaches are packed with people from all over the City trying to escape the heat. To allow beach living for the unhoused will result in (1) denial of the use of the beach to other residents and (2) pollution to our beaches and ocean as these parking lots do not have the facilities for full-time use. 3. Has the Coastal Commission been contacted regarding the legality of this? 4. Housing people in an area without easy access to basic services does not solve problems. 5. Has it been considered that opening the beach as housing will attract more unhoused people to this area? This could be a draw from other parts of the country, not only the city and state. Who wouldn't want to live at the beach? 6. Have the bordering cities (Santa Monica, Culver City, Malibu) been consulted as this will certainly have an effect on their budgets? 7. Has additional funding been earmarked for emergency services? I request that you consider the above prior to voting. I also request that you consider other locations that will have less of an impact on the rest of the city's population to use public space. As you may have noticed, during the pandemic our parks and beaches are being used by many residents as (for many months) these were the only outdoor spaces available. To remove these (which is effectively what will happen) from the public's use is unconscionable.

To allow permanent homeless communities would, in effect, limit other citizens' comfort and safety in those areas, and degrade the quality of life for the majority of taxpaying citizens. We need to find alternate solutions to the homelessness problem in LA. If we can afford to provide housing for the homeless, it should be modest, intended as a temporary stopgap measure, and in non-prime real estate areas. Surely, the leaders of our local government can be more practical and creative than ceding our precious public resources to this problem. There may be areas outside the confines of LA, in industrial areas or unused land where modest housing (multi-family units) can be constructed. Homeless people should be subject to vagrancy laws if they refuse to accept alternate accommodations. I also do NOT support giving homeless people hotel vouchers, which is clearly not the most cost-effective solution for the city. Once covid is over, hotels will be needed to support tourists and business visitors who support our local economy. Homeless hotels would reduce the supply of hotel rooms. Finally, our leaders need to realize that homelessness is a quality-of-life issue that has already begun to drive much-needed taxpayers out of the city. The longer the problem persists, the greater the exodus from this city, and the more tax revenue will be lost. Comments for Public Posting: Opposition to homeless housing at Will Rogers State Beach and other public spaces The Riviera Estates Association is an HOA with 147 properties, whose owners, mostly couples and families, on L.A.'s west side. At this month's Board Meeting, there was unanimous DISAPPROVAL of Mike Bonin's motion to create homeless dwelling spaces in the parking area of Will Rogers State Beach and other public spaces. Pacific Palisades already has a homeless task force. This is the organization the city should be working with to find answers. The homeless problem cannot be solved by subsidizing the homeless or giving them permission to live in public spaces. If you are somehow unaware, the homeless tent "city" on the sidewalks along San Vicente in Brentwood is a disaster. It's dangerous for pedestrians, exemplified by the recent stabbing over Easter weekend. It's a filthy health hazard with the inescapable smell of human urine everywhere and it has had a negative impact on businesses in the vicinity. It should be removed. We have seen how the homeless have ruined Venice where it's now too dangerous to go, to the detriment of our entire city as well as tourists who spend money here. We are stunned that, given these examples, anyone would want to create a situation that will make beach going even more dangerous and a health hazard. The public beaches are enjoyed by ALL the people of the L.A. Area as well as the tourists who spend money here. It is wrong to disregard the rights of everyone to safe and sanitary beaches by sacrificing a primary recreation area, for the benefit of a few homeless people who have no reason to be there and who will bring trouble with them. It will also be dangerous to the homeless who are relocated there (if they even want to be), since they will have to cross 6 lanes of PCH multiple times a day. And building new shelters is a waste of money when there already enclosed site throughout the city. Therefore, we again urge you to vote down the motion regarding housing the homeless at the Will Rogers Beach Parking Lot and other public spaces. Instead, you should work with the Palisades Task Force on the homeless and investigate actions that will permanently get the homeless off of our public streets and public spaces and thereby make the city a safe place to live.
