Dear Councilmember Kevin de Leon,

I'm writing to voice support for Green Qween's cannabis license application and urge you to help move it forward. As a social equity business, Green Qween will make a significant contribution to the DTLA community by helping minority-owned startup cannabis brands breakthrough. In addition, it will provide direct financial support to the forthcoming DTLA Proud Center, which will offer critical mental health and career services for LGBTQIA+ people.

As the CEO of WYLLow, a Los Angeles-based bi-racial, woman-owned equity cannabis brand, I understand the challenges that minority-owned brands face in order to get product on shelves and to compete in a predominately white, cis-male dominated industry. As an example, 50% of products at MedMen are also owned by MedMen, and the remaining space is sold to the highest bidder completely locking out upstart brands. The LA community needs more BIPOC-led startups to succeed in cannabis.

Green Qween will give minority and women-owned brands priority access to shelf space and create a counterbalance that enables them to better compete. For most bands, getting their first few contracts is both the most difficult and the most critical part of their journey as it puts their products in front of real consumers who vote with their dollars.

All of us at WYLLow strongly urge you to support Green Qween's application. Now is the time to promote social equity and diversity in cannabis and in our community.
