Subject: **POSTPONEMENT OF SALARY INCREASES FOR NON-REPRESENTED  
AIRPORT POLICE CLASSES – AMENDMENT TO ORDINANCE NO. 186937****RECOMMENDATIONS**

The City Administrative Officer recommends the following actions by the City Council and Mayor:

1. That the City Council, subject to the approval of the Mayor, adopt the attached ordinance, approved as to form and legality by the City Attorney, amending Ordinance No. 186937, to postpone previously scheduled salary increases for the non-represented classes of Airport Police Commander (Code 3233), Assistant Airport Police Chief (Code 3234), and Airport Police Chief (Code 3232); and
2. That the City Council authorize the Controller and the City Administrative Officer to correct any clerical errors, or, if approved by the City Attorney, any technical errors in the above ordinance.

**SUMMARY**

The ordinance submitted herein amends Ordinance No. 186937 to provide revised salary increase dates for the non-represented classes of Airport Police Commander (Code 3233), Assistant Airport Police Chief (Code 3234), and Airport Police Chief (Code 3232) to be consistent with the revised dates approved by the City Council for postponing salary increases for the City's non-represented classes (C.F. 19-1164-S2). The revised dates are as follows:

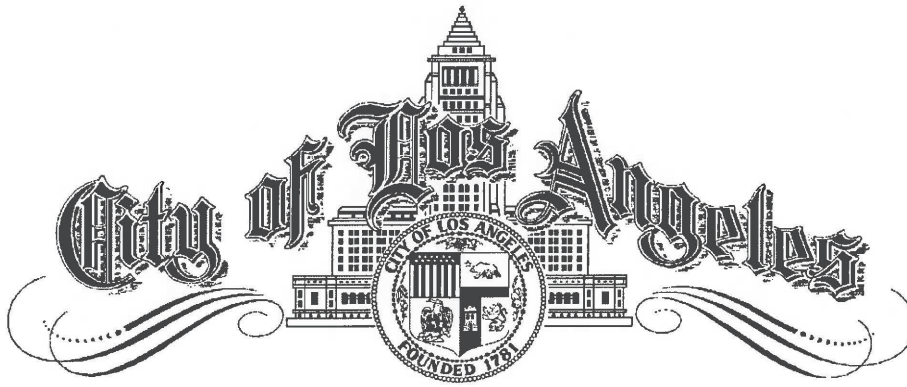

An ordinance amending Ordinance No. 186937 to postpone salary increases for new, non-represented classifications of Airport Police.

**THE PEOPLE OF THE CITY OF LOS ANGELES  
DO ORDAIN AS FOLLOWS:**

Section 1. Section 4 of Ordinance No. 186937 is amended to read as follows:

The provisions of Section 3 of this Ordinance shall be operative June 19, 2022.

Sec. 2. Section 6 of Ordinance No. 186937 is amended to read as follows:

The provisions of Section 5 of this Ordinance shall be operative January 29, 2023.

Sec. 3. Section 8 of Ordinance No. 186937 is amended to read as follows:

The provisions of Section 7 of this Ordinance shall be operative June 18, 2023.

Sec. 4. Section 12 of Ordinance No. 186937 is amended to read as follows:

The provisions of Section 11 of this Ordinance shall be operative June 19, 2022.

Sec. 5. Section 14 of Ordinance No. 186937 is amended to read as follows:

The provisions of Section 13 of this Ordinance shall be operative January 29, 2023.

Sec. 6. Section 16 of Ordinance No. 186937 is amended to read as follows:

The provisions of Section 15 of this Ordinance shall be operative June 18, 2023.

Sec. 7. This ordinance shall be effective upon publication, pursuant to Charter Section 252(g).

Sec. 8. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
