I am here to speak on agenda item #1, specifically the Mayor's 2021-22 budget. I am asking the Budget Committee to restore Recreation and Park's hiring authority for 140 staff positions that were lost to early retirement during the pandemic. The inability to refill 140 positions of Rec & Park staff will have a disproportionate impact on all communities in the City but will most significantly impact communities of color. 1. First, the majority of positions that have been vacated are from within the Land Maintenance Program – when parks are not well-maintained community members do not feel safe accessing them. When parks aren't well used they can become places for unwanted activity, adding further to the feeling that they are not safe places for families to thrive outside. 2. Second, many positions listed are from the Recreational Programming section- a section that often hires directly from the community. By not refilling these position, good paying jobs with growth potential are cut off from communities that most need this type of economic opportunity. 3. Third, COVID-19 has clearly demonstrated the inequities in our park system. Many people had the opportunity to get outside during the pandemic and remain safely distanced, many more people did not. Losing the ability to refill 140 positions will only further exacerbate the inequities in LA's park system. The Department's leadership has demonstrated a commitment to closing the equity gap in access to park space, but without the necessary staff to do the work, how will they be able to get this done? Access to parks is a determinant of mental and physical health and nothing has brought this fact to bear more than the current health crisis. We must consider the long-term impacts on community if these positions are not refilled, just when it is so critical that people get outside to their local parks. Your decision today is critical to ensure that years do not go by with a huge gap in RAP staff which would be detrimental to both the health of our park system, and the mental, social and physical health on our communities. We need your help to make the right decision to continue to keep our parks stable and safe.

We are experiencing an unprecedented crisis in housing with more people living on the street than I have ever seen in my ten years living on the same block. I sometimes have to step over people and wonder if I have seen a corpse. To be clear, this problem is not the fault of people experiencing homelessness, but a sheer lack of effort or political will of this council to divert the necessary resources from bloated, militarized policing budgets into solving our city's internationally notorious homelessness issue. Comments for Public Posting: I am writing to express my extreme disappointment in the Mayor's so-called "Justice Budget," and my hope that the City Council will exercise some independence and vision in shepherding a more progressive budget that truly meets this moment in history. It is impossible to talk about the Mayor's budget without addressing the elephant in the room: the massive allocation for LAPD. In responding to public pressure last year and announcing a \$150 million cut to LAPD last year, Mayor Garcetti was acknowledging that his original budget was not in step with the times. He said he saw this move as "an inflection point," and that he was "committed to making this moment not just a moment." A year later, it seems we are back to the status quo. The moment was indeed just a moment, a blip on the screen, and not a genuine turning point. Rather than continuing to divest from policing & punishment & incarceration, the Mayor has restored LAPD's budget to an amount comparable to last year's initial allocation. It should be noted that Council President Martinez last year echoed the theme of an inflection point and pivot. The cut to LAPD, she said, is "just one small step... as we reset our priorities in the wake of the murder of George Floyd." If the Council approves the Mayor's current budget without dramatic changes, these words will have been proven hollow. For her and City Council, last year's moment will have just been a moment. Let me finish with one telling example of the human cost of Mayor Garcetti's Status Quo Budget. Three years ago the City (in partnership with the County and private foundations) launched the LA Justice Fund, which provides legal representation for community members facing deportation proceedings. The initial funding was for a limited two-year pilot to assess the efficacy of the program. Last year the Mayor allocated \$1 million to LAJF as "bridge funding" while waiting on reports from the County, USC, and others. This bought the program another year but also left it in limbo. With future funding up in the air, it was impossible to build capacity or grow the program. A year later the reports have weighed in with a clear consensus: The program is highly effective at keeping immigrant and mixed-status families together, so effective that it merits a long-term commitment and expanded access so it more closely resembles the universal right to due process offered by our Public Defender model. These reports recommend an initial

2-year allotment of a little over \$3 million a year--not an extravagant amount, but enough to build toward the vision of a guarantee of due process in immigration court. (And a fraction of a percent of LAPD's oversized budget.) A true Justice Budget would pursue such a vision of expanded due process. Instead, the Mayor's Status Quo Budget merely continues last year's bridge funding, putting this essential program in continued limbo. The pandemic has revealed just how flawed and precarious our social safety nets are, especially when it comes to the most vulnerable among us. The Mayor's refusal to commit to a Justice Budget, and to building on the promise of the 2-year LAJF pilot, leaves immigrant and mixed-status families in limbo themselves, even as ICE and Border Patrol continue their predatory policies, and as the backlog in LA Immigration Court exceeds 70,000. The most diverse and immigrant-rich city in America deserves better leadership. Let's see if its City Council can step up and provide it.

Comments for Public Posting: LAPD continues to escalate violence in Los Angeles neighborhoods, with 15 shootings by LAPD (updated this week) so far this year. As in previous years, LAPD continues to respond to calls for help or calls regarding a person in crisis by shooting or killing the person in crisis. The Mayor of LA continues to increase the budget for LAPD. The city should be investing in community services and alternatives to a police response and REDUCING the police budget. The expenses below are contrary to the goal of increasing public safety, and will instead have the effect of making legitimate protest more difficult and dangerous. LAPD has combined all 106 recommendations from three city-requested "after-action" reports into an "Implementation Plan" that would require \$67 million in new spending, including the following: \$53.1 million for new trainings, including \$663,000 just on bullets to shoot at these protest trainings \$4.1 million for a new bureau that will be charged with policing protests \$2.4 million to hire officers who will engage "community members and leaders likely to organize and participate in First Amendment assemblies" \$800,000 for surveillance technology including "software to analyze open-source internet and social media content to provide field operations with vetted and useable intelligence/information" \$492,000 for new policies on Field Jails, \$99,428 to train drivers for buses and vans for mass arrests of protestors \$300,000 for "encrypted radios or another form of private communication" \$125,000 for upgraded technology for the "shadow teams" that infiltrate protests as well as to "study potential new technology for use in public order policing operations" Citywide protests against LAPD violence should be leading to a dramatic reduction in the police budget. The above expenses are completely opposite to what the community and the protestors are demanding. These are constituents and voters who are trying to make their voices heard in an increasingly hostile environment.

I am asking the Budget Committee to restore Recreation and Park's hiring authority for 140 staff positions that were lost to early retirement during the pandemic. The inability to refill 140 positions of Rec & Park staff will have a disproportionate impact on all communities in the City but will most significantly impact low-income communities of color. First, the majority of positions that have been vacated are from within the Land Maintenance Program – when parks are not well-maintained community members do not feel safe accessing them. When parks aren't well used they can become places for unwanted activity, adding further to the feeling that they are not safe places for families to thrive outside. Second, many positions listed are from the Recreational Programming section- a section that often hires directly from the community. By not refilling these position, good paying jobs with growth potential are cut off from communities that most need this type of economic opportunity. Third, COVID-19 has clearly demonstrated the inequities in our park system. Many people had the opportunity to get outside during the pandemic and remain safely distanced, many more people did not. Losing the ability to refill 140 positions will only further exacerbate the inequities in LA's park system. The Department's leadership has demonstrated a commitment to closing the equity gap in access to park space, but without the necessary staff to do the work, how will they be able to get this done? Access to parks is a determinant of mental and physical health and nothing has brought this fact to bear more than the current health crisis. We must consider the long-term impacts on community if these positions are not refilled, just when it is so critical that people get outside to their local parks. Your decision today is critical to ensure that years do not go by with a huge gap in RAP staff which would be detrimental to both the health of our park system, and the mental, social, and physical health of our communities.

Comments for Public Posting: I am a removal defense attorney with the Immigrant Defenders Law Center and this comment is regarding the Mayor's minimal allocation of funding to the LA Justice Fund (LJF). LJF has proven its success time and again in keeping Angeleno families together and mitigating the harmful effects of the immigration detention and deportation system on Angelenos. LJF was successful as a pilot program from 2017-2019 and even somehow managed to succeed on the very limited bridge funding provided last year. Since its inception, there have been several reports published documenting the successes of and the need for LJF. In fact, both the City and the County explicitly commissioned independent reports to evaluate the effectiveness of LJF, and both of these reports (written by the Grantmakers Concerned with Immigrants and Refugees (GCIR) as well as USC's Dornsife Equity Research Institute) overwhelmingly supported not just the continuation of LJF, but a significant expansion of LJF. And yet once again, LJF is forced to beg for a budget that reflects the true scale of the problem and the realities of removal proceedings. Despite the Mayor's claims that this proposed budget is focused on racial equity and social justice, the Mayor is proposing to allocate over \$3 Billion to LAPD – amounting to almost half of the City's total budget – while simultaneously only allocating \$1 Million dollars to the LJF. A program that since 2017, has provided literally thousands of people in immigration detention the opportunity to speak with an attorney about their case, has provided full-scope legal representation to nearly six hundred Angelenos, has created dozens of jobs for attorneys, paralegals, and case managers at legal service providers, has supported Angelenos affected by the pandemic, and has connected thousands of people to City and County support services. LAPD has continued to target, harass, and kill people of color. There should be no need for discussion, the City Council cannot support the Mayor's budget as it is proposed today. By proposing a budget that increases funds to LAPD while barely funding LJF, the Mayor is completely ignoring the continued calls from Angelenos to defund LAPD and instead fund justice programs like LJF, that actually support the community. LJF is a due process issue as much as it is a racial equity issue. Similar to the criminal punitive system, the immigration detention and deportation system

disproportionately affects communities of color. If the City of Los Angeles genuinely wants to invest in racial equity and support its immigrant communities, funding LAJF is one of the most tangible and direct ways to do that. If the Mayor's funding suggestion is what LAJF ultimately receives, it simply is not enough to continue LAJF and the infrastructure that the City, County and philanthropy have helped build over the past four years will undoubtedly crumble. In 2017, LA was at the forefront of the movement, however, since then, while other cities all over the nation, including neighboring cities like Long Beach and Santa Ana, have stepped up and established holistic removal defense programs to protect their immigrant communities, increasing their funding each year – LA has fallen more and more behind. Instead of stepping up, the Mayor's budget is proposing that LA step back. I urge you all to show the Mayor that protecting Los Angeles' immigrant communities and fighting for racial equity, is worth the \$6.42 million needed to continue and expand LAJF over the next two years. - The spending plan must include investments in women and children, restorative justice, guaranteed basic income and increased access to housing.
- The spending plan must be created with an eye toward transparency and include metrics to track success.
- Community programs and initiatives must be prioritized and not be the first to be eliminated - if budget assumptions are not met during the year.
- A demonstrated commitment from the new Office of Racial Equity to formulate an equity index of indicators that shows the most significant areas of need throughout Los Angeles.

We encourage the members of the Budget and Finance Committee to support the goals and programs outlined in the Mayor's Proposed Budget and take meaningful steps to ensure their funding and execution.
