**Comments for Public Posting:** Dear Chair Krekorian and other members of the Budget and Finance Committee, My name is Chelsea Bell and I use the pronouns she/her/hers. I am a removal defense attorney with the Immigrant Defenders Law Center and have had a Los Angeles Justice Fund (LAJF) caseload since 2018. I cannot urge you and the other Budget committee members strongly enough to support LAJF. In order to move forward, LAJF needs to be made permanent with multi-year funding and needs to be made more holistic by removing the criminal carve out and redefining the residency requirement. After a year of consistent social unrest based on racial inequities and a global pandemic that ripped through communities of color in Los Angeles, the City of LA has the opportunity to address both of these issues with one action: fully funding the LA Justice Fund. Not only is LAJF an issue of racial equity, but LAJF has been supporting immigrant Angelenos directly affected by COVID-19 since the very first case was detected in LA. Since its inception, LAJF has provided literally thousands of people in immigration detention the opportunity to speak with an attorney about their case; has provided full-scope legal representation to nearly six hundred Angelenos; has created dozens of jobs for attorneys, paralegals, and case managers at the LAJF legal service providers; has supported Angelenos affected by the pandemic; and has connected countless Angelenos to life-saving services. In 2020, despite LAJF's continued success, the City and County insisted on providing limited bridge funding, while they commissioned evaluations of LAJF from third-parties. The reports commissioned by the Board of Supervisors (by Grant makers Concerned with Immigrants and Refugees) and the City Council (by USC's Dornsife Equity Research Committee), overwhelmingly supported not just the continuation of LAJF, but a significant expansion of LAJF. Given the undeniable successes and obvious merits of the program, the Budget and Finance Committee members should vote to provide LAJF multi-year funding. Multi-year funding is the only way to ensure that the incredible infrastructure that LAJF built of detained removal defense attorneys - which took five plus years of work and millions of dollars - doesn't crumble. The \$1M allocated by the Mayor to LAJF is simply insufficient for legal service providers to maintain staff and resources for LAJF cases, which can last

several years. I urge the Budget and Finance Committee members to provide additional multi-year funding to LAJF. In doing so, the City is making a vocal commitment to racial equity and due process for ALL, no matter an individual's background or residency. To be a truly universal defense representation program, LAJF must not have ANY exclusions and must be a multi-year program. A permanent and universal Los Angeles Justice Fund would protect all human beings facing deportation in immigration court. LA should lead the rest of the country with this fund. It is one thing to say that our city of Angels protects immigrants, but it is another thing for our budget to actually reflect those values. We cannot allow immigrants who have suffered the most and given the most during the Pandemic to continue to be vulnerable to unjust federal policies. Leaders, like you, have an opportunity to invest in long-term and systemic solutions to help the most vulnerable Angelenos. We implore you to do the right thing- fully fund this critical civil and human rights infrastructure. LAJF is a jointly-funded program by the City, the County, and philanthropy, as it should be, because it affects Angelenos from all walks of life. The City should do its part by allocating one-third of the program costs: \$6.42 million over the next two years, with \$3.16 million earmarked for Year 1 and \$3.26 million for Year 2. This amounts to only .00028% of the City's annual \$11.2 billion budget (and about .01% of the LAPD's \$3+ billion budget). In 2017, LA was at the forefront of the movement, however, since then, at least 43 other cities all over the nation, including neighboring cities like Long Beach and Santa Ana, have stepped up and established holistic removal defense programs to protect their immigrant communities, increasing their funding each year – LA has fallen more and more behind. Instead of stepping up, the Mayor's budget is proposing that LA step back. I urge you vote to fully fund LAJF. Protecting Los Angeles' immigrant communities and fighting for racial equity, is worth the \$6.42 million needed to continue and expand LAJF over the next two years. Respectfully,
