**Comments for Public Posting:** Greetings L.A. City Council, I am writing in my personal capacity, I have been a downtown resident since 1990 and part of the LGBTQ community. I have worked in our night life and fashion communities. Locally I created HelpingPlaces.org, WatchDTLA.com and iHeartDTLA.com to be of service to my communities that I love so much. I have also worked with the L.A. Mission, Compass DTLA, property management and served on DLANC (not an active board member and did not vote on the letter of support). I feel that Green Qween's Founder, Andres Rigal, will likely be accountable for any of the socially equitable initiatives that he has offered. Andres is a community builder and unifier in our Los Angeles LGBTQ community. Andres has done many successful projects including the DTLA Proud festival, where a rainbow of people of including people of color, drag and trans were able to celebrate their diversity at the very successful DTLA Proud that had an attendance of tens of thousands and has a board established with key downtown figures. I have found out that Andres is a downtown resident since the early 2000's and seems very committed and I do not believe that he would be a "fly by night" operator that would make claims and not follow through with them. The quality of community building that Mr. Rigal practices is a very rare thing to come by. From the Green Qween website: "Green Qween will honor queer history in cannabis legalization by focusing on giving back through and equity in hiring program, incubating LGBTQ & Women owned brands, and donating 10% percent of all profits to build and then fund the DTLA Proud (501c3) LGBTQ+ Community Center." I feel it is so important to give opportunities to communities who are overlooked or don't have the resources to enter a market place and I love supporting LGBTQ and Women's brands. I was very excited when I first heard of Green Qween using proceeds to help open a DTLA LGBTQ Center, this is so very badly needed in the established and growing LGBTQ area of DTLA. I feel the LGBTQ communities have been migrating from West Hollywood and Silver Lake to DTLA and we now have so many of these residents and small business owners that a LGBTQ Center will help better serve. LGBTQ people cannot exist openly in most part of the city or state, except for in a handful of pockets where they feel safe to express themselves, wear clothing that suits them or
