Harassment in all forms by any party is unacceptable. I have been harassed many times as a gay man, as the father of a trans daughter – and lately as a housing provider. Especially since I've been the victim of harassment, I am empathetic to those who experience harassment, and especially committed to eliminating harassment. The best way to eliminate harassment is to promote communication, understanding and empathy, not by unduly punishing one party without condition. Reducing or eliminating harassment is the goal – not punishing without even the opportunity to engage in conversation. I know from my personal experience that this latter approach is the only one that works in the long term. This is why I appreciate your previous (and on-going) work on this issue. This is why the original draft language is so important – it provides a reasonable standard for defining harassment, and more importantly, effectively mandates that communication occur. Requiring that rental housing providers be given written notice of any alleged violation and a reasonable opportunity to remedy the issue is the way to educate and reduce harassment. That this was directed by your committee in the first place. Please don't support Councilperson Raman's proposed language which will only promote antipathy between housing providers like me and those who make their home in that housing I try so hard to ensure is a wonderful place to live.
