Hello,

Unfortunately I was unable to attend the live public comment session earlier today, but I would still like to express my support for agenda items 5, 6, and 8. I live in Venice and would directly benefit from both item 5's improvements to bike infrastructure and item 6's signal priority for the Expo Line. Much of the city and county remain inaccessible without a car, and these agenda items are crucial to make progress on this front. I look forward to a day when I no longer need to own a car to get by.

I would also like to mention the importance active travel infrastructure has for the mobility of older and disabled people. The current state of the sidewalks and paths is abysmal. Between the frequent corners with no ramps, uneven surfaces, and obstacles like street lamps and utility poles, it is difficult to impossible for anyone to get around using a wheelchair, mobility scooter, walker, or stroller. Properly built sidewalks and separated bikeways are necessary not just to reach our climate goals but also to make the city more accessible.

Item 8 is important for reducing both greenhouse gas emissions and local air pollution. Combined with the infrastructure improvements from item 5, the potential for more deliveries to be made by electric cargo bikes instead of large trucks and vans would improve safety and reduce noise pollution.
