SUBJECT:

Grifols Way and Mariondale Avenue – Private Driveway Name Establishment at Mariondale Avenue and Lillyvale Avenue – R/W No. 36000-2192

RECOMMENDATIONS:

- A. That the name of the public streets being vacated, Mariondale Avenue and Lillyvale Avenue, shown on Exhibit “A”, be established as Mariondale Avenue and Grifols Way (Private Driveways).
- B. That the Council, find that the name establishment is exempt from the California Environmental Quality Act of 1970, pursuant to Article III, Class 5(4) of the City’s Environmental Guidelines.
- C. That the City Clerk be instructed to transmit the following:
 - 1. A copy of the City Council’s action on this matter to the Board of Supervisors of the County of Los Angeles pursuant to Section 34092 of the Government Code.

DISCUSSION:

Request: The petitioner, Karen Glenn, is requesting the City to establish the name of the streets being vacated lying on Mariondale Avenue and Lillyvale Avenue, as shown on Transmittal 2 Exhibit "A", as Mariondale Avenue (Private Driveway) and Grifols Way (Private Driveway).

The name establishment for the private driveway is required to re-establish Mariondale Avenue as previously recognized, and to establish the private driveway, currently shown as Lillyvale Avenue, to be changed to Grifols Way, in response to the vacation conditions adopted by Council on September 21, 2018 under Council File 17-0504 relative to the street vacation request.

The naming of the private driveway does not signify that it is either a public street or approved private street and is for identification purposes only.

Upon adoption of the Report by the City Council, the adjoining property owners and concerned agencies will be notified of the name establishment.
