Summary: WHEREAS, on January 6, 2021, pursuant to the 12th Amendment to the Constitution of the United States, the Vice President of the United States, the House of Representatives, and the Senate met at the United States Capitol for a Joint Session of Congress to count the votes of the Electoral College; and WHEREAS, during this Joint Session of Congress a violent crowd unlawfully breached and vandalized the Capitol, injured and killed law enforcement personnel, menaced Members of Congress, the Vice President, and Congressional personnel, and engaged in other violent, deadly, destructive, and seditious acts; and WHEREAS, the intent of the crowd was to interfere with the Joint Session's solemn constitutional duty to certify the results of the 2020 Presidential election; and WHEREAS, said conduct gravely endangered the security of the United States and its institutions of Government, threatened the integrity of the democratic system, interfered with the peaceful transition of power, and imperiled government workers and officials; and WHEREAS, such conduct demonstrates that the people involved are a threat to national security, democracy, and the rule of law; therefore, BE IT RESOLVED, that the Hollywood Studio District Neighborhood Council (HSDNC) supports Council File 21-0051 to investigate city employees' involvement in the insurrection; and BE IT FURTHER RESOLVED, that the HSDNC supports removal from office any city employee, especially employees of the Police Department (LAPD) and Fire Department (LAFD), who were involved in the insurrection at the Capitol on January 6th.
