My children went to preschool less than half a mile from the Allen Co site, and they had frequent nosebleeds in those years. We had no idea there was a drill site next so close. My son currently goes to Mid-City Prescott school and has asthma, along with many of his classmates. When they run around and play outside, they are breathing the burn off gas pollution from the Murphy drill site less than half a mile down the street. My mother and father in law live in St John's Retirement Center which is across the street from the Murphy Drill Site. If there were an explosion at the Murphy site from the multiple gas leaks there, they and all of their neighbors would be injured if not killed. Oil drilling and oil processing operations have absolutely no place in the city of LA. We need you - our elected officials - to protect us. Please vote yes on to phase out oil operations in LA.
