**CITY OF LOS ANGELES NOTICE OF PUBLIC HEARING**  
The Los Angeles City Council will hold a Public Hearing relative to an Ordinance amending Article 1, Chapter VII of the Los Angeles Municipal Code to replace the existing shared mobility device pilot program with an annual permit program. The Ordinance establishes the following program fee: A provider of a shared mobility device shall pay an initial permit fee in the amount of \$20,000.00, an annual permit renewal fee in the amount of \$20,000.00, and trip fees in the range of \$0.06 to \$0.40 per trip. The Los Angeles Department of Transportation shall determine and calculate the trip fees by the geographic zone where a device is operated.  
The Public Hearing will be held Wednesday, March 24, 2021, at 10:00 am, or as soon thereafter as the matter can be heard, in the John Ferraro Council Chamber, Room 340, City Hall, 200 North Spring Street, Los Angeles, CA 90012. The City Council reserves the right to postpone or continue this matter to a later date, subject to any applicable time limit constraints.
