Enforcing this ordinance would effectively criminalize unhoused Angelenos from occupying spaces that are PUBLIC—creating a situation where unhoused folks will lose access to many of their basic needs and supportive services. Such cruel attempts to sweep our unhoused neighbors out of sight not only fails to solve systemic housing and economic problems in our city, but also exacerbates these issues and puts unhoused folks at risk to face aggressive and excessive force from city employees and police, as we have seen very recently with the sweeps in Echo Park. Rather than passing such inhumane ordinances, the city needs to prioritize the creation of infrastructure that allows these folks to have access to the services they need and have full autonomy over their lives. Further, such infrastructure should put the interests of unhoused folks first instead of having shelter staff or other public officials determining what is “best” for them. We need to treat our unhoused neighbors with the dignity and respect that all people deserve, and reject ordinances such as this one that will dehumanize folks just for occupying public space.

Having been homeless myself, after cancer, chemo, and losing my livelihood, I do realize that there are those that could use a helping hand in order to get their lives back on track. These are not the people living on the streets that I witness on a daily basis. What I witness, are homeless people who have chosen to live on the streets so they can do drugs and abuse alcohol, rather getting clean, following rules and conforming. We have a guy who's taken over the sidewalk and continues to take more of it down the street from our home. I have seen people give him cards with information where he can get help. He has told them flat out.... he is not interested! I don't even walk down (as others who live near me) my street anymore because of him and the drugged out and or drunk homeless that he brings to the street and are taking over. Having them where I have a business, has also impacted my business. I am the one who pays, not only homeowners taxes but business taxes, they pay nothing. I have had a homeless woman who setup camp across my street for months, hit me. I woke up to a man in my bedroom one morning. It was the scariest thing I've ever experienced. When the police arrested him, he told them he lived in the vacant apartment building across the street also. He told my husband and I that he was "cracked out". I have been told by the police on several occasions. My rights are "less" than those who "choose" to do drugs, drink excessively, and live on the streets for free. These people know it. They know they can do just about whatever they want and get away with it. When the guy broke into my house, I was told by one of the officers that he would be charged with a felony. Only to be called by the very same police officer later in the day, to be told that the detectives just charged him with trespassing and that he was already out of jail. Free to do drugs and commit more crime. The homeless situation has gotten completely out of control. If our local government does create stronger mandates and laws to protect law abiding citizens and giving them more rights, it is my belief, citizens are going to start

taking matters into their own hands. Where will that leave us? It is time our local government starts working for those of us who pay their salaries, not for drug addicts alcoholics who would rather live on the streets creating havoc, more crime and unsanitary situations for us to live in.

Having said that, I am terrified to walk alone in my neighborhood even during the day, I am no longer able to take my children for a walk around the block because every single time we go out, we run into someone who is either passed out on the street in front of us, taking drugs, or acting aggressively and erratically. I have also witnessed people throwing rocks at cars, fighting under the freeway overpasses and frankly I am frightened even driving by and stopping at the lights in the underpasses when I pick my children up from preschool. I want to support people to get the help they need and do not believe in criminalizing people who have nowhere else to go, but as I understand it there are a number of homeless shelters which are not full - so surely they do have somewhere to go? Also would passing this law prevent outreach from happening? It seems to me that perhaps this law would only encourage people into shelters and outreach programs, rather than allowing drug abuse, homelessness and a further descent into mental illness to continue unchecked? Homelessness is a very complicated issue, but at the end of the day I do not think it is acceptable for residents to be afraid to walk the streets or literally unable to pass by due to people unconscious or fighting on the sidewalk or groups of tents blocking the path that are frankly very intimidating to solo female pedestrians. I want to be able to take my kids for a walk without fear, so I support this proposal. I also support paying taxes to help fund structured programs and sheltered to help these people so that they do have somewhere to go, and a path back to reintegration. I do not think just allowing people to live in tents wherever they like and act however they like, with zero consideration to others, is a fair or sensible solution to this crisis.

Comments for Public Posting: I am an epidemiologist and faculty at UCLA School of Medicine. My lab conducts research and community-based public health work on homelessness, overdose, and infectious disease (including COVID and most recently street-based COVID vaccine clinics). We are concerned about the potential of the proposed changes to LA municipal code 41.18 to impact our work, particularly in providing vaccines and overdose prevention resources. To better understand, we made a map but found that some rules were a bit unclear. The map can be viewed here: <https://storymaps.arcgis.com/stories/603d90d620984f79ad843c2d3f77ceff> I also sent a copy of our map to each member of the City Council to ask if they had a map they were using to consider the proposed change. So far, no one has provided one. This suggests to me that the spatial analysis of determining where people CAN sit, sleep, or camp has not been adequately considered. This is concerning because of the far-reaching buffers proposed around schools, libraries, and certain shelters and service providers. Once you add all of those, there are some neighborhoods where there is no space where one can sit, lie down, sleep, or camp. I appreciate the response of some councilmembers to my team's inquiry, and am available to speak with anyone who wants to discuss our methodology or other aspects of housing and public health. In brief, my colleagues and I are concerned that this ordinance, if enacted, would make it extremely hard for people to find places to stay in absence of enough shelter beds – and that the potential for fines and incarceration would further exacerbate the poverty conditions that lead someone to being unhoused. I know we are all motivated to find working solutions for the housing crisis here in LA. But fines and penalties are not the way out of this situation, and indeed stand to make things considerably worse for our unhoused neighbors.

Then, there are the many individuals that stay in abusive relationships due to a lack of housing alternatives. Then, there are those that are displaced from their homes due to their identity who need a safe option to turn to. My point is this: you need to start passing policy that creates a better

world. Stop passing policy that brings more profit to the vultures that benefit from the suffering of others. Do better or resign.
